That the Party of the First Part and the Party of the Second Part hereby agreed and declared that the above mentioned Schedule "A" & "B" properties shall be mutated in their names as joint Owners and/or Co-owners on the record of Andul Gram Panchayet into one holding liable to pay the proportionate taxes jointly.
- 4. That the Party of the First Part and the Party of the Second Part hereby further declare that the properties mentioned in the Schedule "A" & "B" will be amalgamated into a compact and explanatory holding and also the Party of the First Part and the Party of the Second Part will enjoy the same as joint owners and occupiers without any obstruction and/or litigation claim or demand whatsoever in future jointly in respect of the said amalgamated property in the Schedule "C" as would be assessed by the Andul Gram Panchayet.


