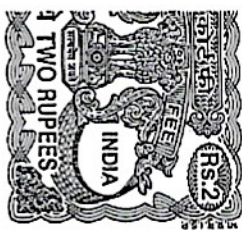

Perused the petitions filed by the petitioner and gone through the xerox copy of the will and materials on record.

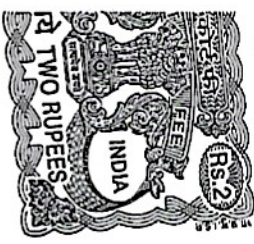
It is stated by the executor/petitioner the ~~state~~ estate of Lt. Rabintra Nath Mukherjee has been fully administered interims of Probate granted.
