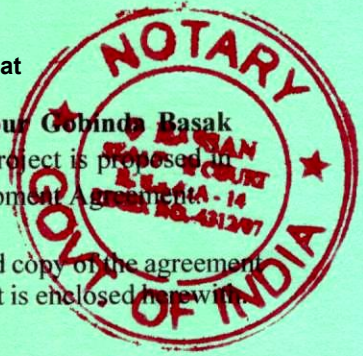

1.
