3. That the time period within which the project shall /promoter is 01/03/2026.

- 4. That seventy per cent of the amounts realized by me/promoter estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a schedule bank to cover the cost of construction and the land cost and shall be used only for that purpose.
