The Plan of Plot No 17

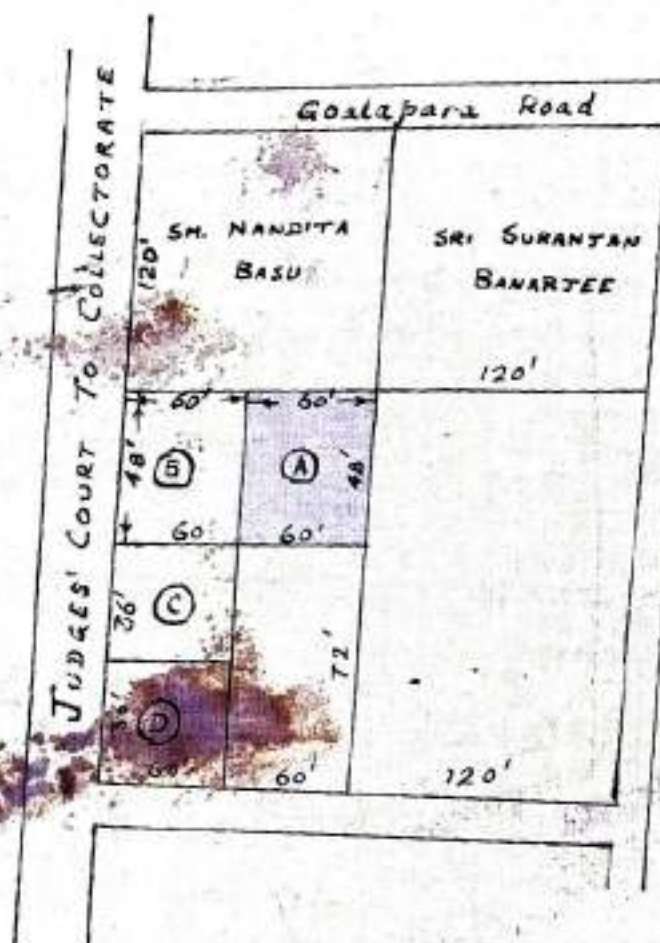
