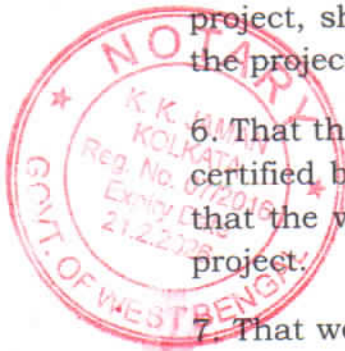
3. That the time period within which the project shall be completed by us is 30/09/2025
