TITLE INVESTIGATION REPORT

As per the instruction of my client I have thoroughly gone through the title deeds supplied to me in the name of Uttam Kumar Shaa pertaining to the 34.648 Decimal along with other properties in R.S. Plot No. 1571, 1572 & 1599 corresponding to L.R. Plot No. 1722, 1723 & 1740 respectively of Mangalbari Samundai Mouza recorded in his name vide L.R. Khatian No. 2350 (more fully described in the schedule below) and I have made an extensive search at the web portal of Dept. Of Registration & Stamp Revenue, Govt. of West Bengal from the year 2012 to 2024 and also verified the current records of the property from web portal of Land & Land Revenue Dept. Govt. of West Bengal and my findings there from are as follows:

Originally 1) Amiya Kumar Saha, S/o. Lt. Amulya Kumar Saha, 2) Sankari Rani Saha, W/o. Amiya Kumar Saha, 3) Ganesh Chandra Saha, S/o. Lt. Amulya Kumar Saha, 4) Namita Rani Saha, W/o. Ganesh Chandra Saha, 5) Madhusudan Saha & 6) Uttam Kumar Saha, both S/o. Lt. Amulya Kumar Saha, jointly purchased many lands in different plots and mouzas within the Malda district at different points of time in the past, starting from the year 1981.

Thereafter for clear demarcation of their own share in the above said lands and for other conveniences of possession in 1990 all the above said co-owner amicably partitioned their lands among themselves by metes and bounds by virtue of registered Partition Deed No. I-12472 dated 26/12/1990 of DSR Office Malda wherefrom Uttam Kumar Saha as the FOURTH PART acquired 14 Decimal of land in R.S. Plot No. 1572 corresponding to L.R. Plot No. 1723 and 9.9 Decimal of land in R.S. Plot No. 1599 corresponding to L.R. Plot No. 1740, totalling 23.9 Decimal in both plots under Mangalbari Samundai Mouza.

One Harekrishna Das peacefully owned and possessed 6.66 Decimal of land in R.S. Plot No. 1571 corresponding to L.R. Plot No. 1722 of Mangalbari Samundai Mouza which he acquired by virtue of registered Partition Deed No. I-829 dated 27/01/1978 of DSR Office Malda.


During his possession in 2006 Harekrishna Das sold 1.65 Decimal of land from his share in R.S. Plot No. 1571 corresponding to L.R. Plot No. 1722 to Uttam Kumar Saha by virtue of registered Sale Deed No. I-2620 dated 02/05/2006 of DSR Office Malda and put him in possession.

Subsequently in 2009 Harekrishna Das again sold 0.248 Decimal of land from his share in R.S. Plot No. 1571 corresponding to L.R. Plot No. 1722 to Uttam Kumar Saha by virtue of registered Sale Deed No. I-1274 dated 10/02/2009 of ADSR Sadar, Malda and put him in possession.

Thereafter in 2012 on of the above said co-owners namely Madhusudan Saha gifted 5 Decimal of land in R.S. Plot No. 1572 corresponding to L.R. Plot No. 1723 to Uttam Kumar saha by virtue of registered Gift Deed No. I-4471 dated 02/04/2012 of ADSR Sadar, Malda and put him in possession.

One Ashok Saha also peacefully owned and possessed 6.66 Decimal of land in R.S. Plot No. 1572 corresponding to L.R. Plot No. 1723 along with 8.25 Decimal of land in R.S. Plot No. 1599 corresponding to L.R. Plot No. 1740 which he purchased by virtue of registered Sale Deed No. I-5714 dated 02/06/1992 of DSR Office Malda and registered Sale Deed No. I-144 dated 08/01/1988 of ADSR Sadar, Malda.

In this way Uttam Kumar Saha acquired 1.898 Decimal of land in R.S. Plot No. 1571 corresponding to L.R. Plot No. 1722, 21.2 Decimal of land in R.S. Plot No. 1572 corresponding to L.R. Plot No. 1723 and 11.55 Decimal of land in R.S. Plot No. 1599 corresponding to L.R. Plot No. 1740, totalling 34.648 Decimal in all three lands which equivalent to 20.9987 Cottah and it has been recorded in the name of Uttam Kumar Saha vide L.R. Khatian No. 2350 of Mangalbari Samundai Mouza.

I have also made search at the Ld. Court of Civil Judge Senior Division, Malda and Civil Judge Junior Division, Malda in connection with the below scheduled property and found that there is no case or suit pending concerning this possession. No court search receipt was issued by the Ld. Court without any specific case/suit number.

After perusing all the title related documents of Uttam Kumar Saha w.r.t. the below shceduled 34.648 Decimal of land I hereby confirm that Uttam Kumar Saha has absolute right, title, interest and possession over the scheduled property. The scheduled property is freely marketable, free from all encumbrances and fit for creation of equitable mortgage.

I also confirm that no minor's interest is involved with the scheduled property or any part thereof.

It is also found that Uttam Kumar Saha sold 5.01 Decimal of land in R.S. Plot No. 1572 corresponding to L.R. Plot No. 1723 & 0.51 Decimal in R.S. Plot No. 1571 corresponding to L.R. Plot No. 1722 to Rabindra Ghosh, S/o. Krishna Ghosh by virtue of registered Sale
