

Background-Ownership of Property By Dr. Jatindra Mohan Dasgupta

WHEREAS:

- 1. DR. JATINDRA MOHAN DASGUPTA (also known as Dr. J. M. Dasgupta) (Since deceased) was the absolute owner of several properties lying and situate in several parts of Kolkata (Calcutta) including the land measuring about more or less 1 Bigha 7 Cottahs and 4 Chittaks, in Mouza South Ballygunge, P.S. Gariahat, being Premises No. 87, Ballygunge Place, Kolkata 700019, as more fully described in the First Schedule hereunder written and hereinafter referred to as the "Said Property" and more fully described in the First Schedule hereunder written.
- 2. By virtue of a Sale Deed which was duly executed and registered on (15th December, 1926) 15-12-1926 before District Sub-Registrar at Alipore and was

- and 59/1, Palm Avenue and Premises No. 9, Broad Street (more fully described in the Second Schedule hereunder written) subject to the following terms & conditions and directions:-
- a. To perform daily Seva Puja in the temple house at 87, Ballygunge Place called Ram Nibas.
- b. Augment income from the landed properties being the First and Second Schedule properties.
- c. To perform Seva Puja of Sree Sree Iswar Daya Nidhi represented by twin images of Radha Gobinda incarnated in his Gurdev, Sree Sree Ram Thakur.
- d. The testator has directed that the worship of the said Thakur Sree Sree Iswar Daya Nidhi shall be held daily on the first floor of the First Schedule property.
- e. The testator has further directed that the periodical celebrations and special Puja of the said Thakur Sree Sree Iswar Daya Nidhi on the occasion of Akshya Trithiya, which is the holy Janmathithi of Sri Sri Ram Thakur and on the occasion of Ratha Yatra should be made in the same manner and in the same place as the testator used to perform the same.
- f. It is further directed that the gallery of the pictures, photographs, statues and other representations of his Gurudev and writings by and on him of the holy relics connected with him shall be maintained in such portion of the house at the First Schedule property as may be convenient for the view of the Bhaktas of his Gurudev.
- g. It is further directed that in the house of the First Schedule property suitable portion shall be set apart also for the use as places for public congregational prayer to the said Thakur and for Kirtan and Bhajan songs for the recitals of his pleasure for the assembly of the public for discourses or discussions of his life and teachings as a temporary shelter for his bhaktas and admirers, who may visit the place from a far on pilgrimage.
- h. It is further directed that no wall or partition shall be erected at or on the portion of the house in the First Schedule property PROVIDED HOWEVER that if fresh construction can be made providing for better, more convenient and wider areas for the purpose aforesaid, then and to that extent the Trustee shall be entitled to change the venue of the daily worship, congregational prayer, devotional songs and recitals, assembly for discourse and discussions and temporary shelter for pilgrims as referred to above.
- i. Testator further directed that no interest in the properties comprised in the First Schedule properties shall be transferred in any manner partially or fully under any circumstances.

- he testator further directed that the Managing Trustee of the said Trust shall have the right to make such alterations in the location and the place of the worship and retirement of the said Thakur Sree Sree Iswar Daya Nidhi as may become more convenient in course of time for the Thakur in view of the age and state of repair of house of the First Schedule property and for other unforeseen, but for imperative reasons.
- k. The testator further permitted the Managing Trustee of the trust to take loans, when such loans would be necessary to improve the rights of the Thakur and to develop the properties of the Thakur with the permission of the Board of Trustees.
- 1. The testator further directed that all income and accretions from all sources including offerings, if any, by the Bhaktas to the Debutter or to the Deities shall be fully and truly accounted for and such income and accretions shall so far as possible after meeting the current expenses of the Debutter be applied to clear the encumbrances, charges of the First Schedule property and such other activities as more fully mentioned in the said Will.
- m. It was the direction of the testator that Seva shall not at any time be divisible into Palas or Shares, but shall be administered as one Public Religious Trust or Seva or Charitable in nature.
- n. The Board of Trustees shall provide for remuneration and residence of the Managing Trustee.
- o. The Board of Trustees shall provide for the residence and maintenance of the bachelor son of the testator namely Debi Prasad Dasgupta, who has dedicated to the service of Thakur Sree Sree Iswar Daya Nidhi.
- p. Under the said will Smt. Rangan Mala Dasgupta @ Mala Dasgupta was appointed as Executrix and Managing Trustee (hereinafter referred to as the "Managing Trustee") of the said Trust. The properties mentioned in the will became the subject matter of a Private Debottar in terms of the said will.

Learned 8th Court of the Addl. Dist. Judge was pleased to grant probate of the said will on 24th August, 1999 in the probate case being 0.S. No. 4 of 1997

q. After the demise of the said J. M. Dasgupta (hereinafter referred to as the Testator), on 30.09.1975 the said Smt. Rangan Mala Dasgupta @ Mala Dasgupta, the Managing Trustee under the said will, applied for the grant of probate of the said Will and Testament of the Testator before the Learned District Judge of South 24 Parganas at Alipore vide probate case being O.S. No. 4 of 1997.

The Learned the Additional District Judge 8th Court at Alipore was pleased to grant probate of the said will on 24th August, 1999 in the probate case being O.S. No. 4 of 1997. Mutation of the "Said Property" has been effected and comes in favour of Sree Sree Iswar Daya Nidhi represented by Smt. Rangan Mala Dasgupta @ Mala Dasgupta, the Managing Trustee herein.

Managing Trustee filed an application before Ld. Dist.Judge, Alipore, 24 Pargabas for permission to develop the said property without demolishing the existing building

s. As the trust was facing acute financial crisis in order to perform its duties as per the said Will, the Managing Trustee filed an application under Section 34 of the Indian Trust Act 1882 being Misc Case No. 217 of 2001 before the Learned District Judge, Alipore, 24 Parganas (South), praying for permission to develop a potion of the said property by raising construction thereon, without disturbing/demolishing the existing building.

Learned District Judge, Alipore, South 24 Parganas, Order the Trustees to develop the said property

- t. After hearing such application, the Learned District Judge, Alipore, South 24 Parganas, by an order No-20, dated 05.04.2002, (5th April, 2002) allowed the application for permission of the Managing Trustee. The Learned District Judge permitted the Trust through the Managing Trustee for entering in to agreement with the Developer and after payment of all liabilities, the residue of the sale proceeds of the owners' allocation is directed to be invested in any Branch of State Bank of India and liberty was given to collect the interest accrued for seva Puja and festivals and for the management of the Trust. Permission for execution and registration of sale deed was also granted under said order of Court.
- u. In view of the said Order of the Learned District Judge, Alipore, South 24 Parganas, the Managing Trustee has the authority to develop the said property.

The Settlor Dr. J. M. Dasgupta, appointed the following persons as the Trustee of the said TRUST

- The Said Settler Dr. J. M. Dasgupta (Since deceased), also made provisions in the said WILL for co-option of the subsequent trustees in the absence of the Original Trustees.
- 3. In view of continuation of probate proceedings and other legal proceedings, the Trust could not be made formally functional. The Original Trustees, due to their advanced age also did not participate in the trust proceedings. Some of the Original Trustees demised in the meantime.
- 4. It was inter-alia stated in the will that in absence of First Managing Trustee Anjan Baran Dasgupta or if he is not available then Second Managing Trustee Smt. Rangan Mala Dasgupta @ Mala Dasgupta, will continued to carry as the Managing Trustee.
- 5. However, the Managing Trustee Smt. Rangan Mala Dasgupta @ Mala Dasgupta, continued to carry on the directions contained in the Said WILL and performs all activities and seva puja of the Deity.
- 6. The Managing Trustee issued notices / issued notices to the said Original Trustees of the said Trust on various dates latest by 10th July, 2020; however, no response has been received from the original trustees.
- In view of the same, the Trust need to be functional formally and the Trustees are required to be appointed in place of the Original Trustee.
- 8. As there was provision for co-option of the subsequent trustees in the absence of the Original Trustees, the trust in its meeting held on 10th July, 2020, has reconstituted the said Trust and included the New Trustees in the said Trust
- 9. In the said meeting the Trustees (including Managing Trustee) have taken several decisions for smooth and effective functioning of the Trust.

10. The parties herein have decided to record the said decision of the Trust in the manner herein below written.

Now this Indenture witnessed that

The Trustees have agreed to execute this Deed to give effect of the wishes of said Trust created by Late Dr. J. M. Dasgupta and for the ends, intents, and purposes as subject to the terms and conditions contained in this Deed, herein after appearing and has settled a sum of Rs.10000/ (Ten thousand only) in favor of the TRUSTEES.

- NAME OF THE TRUST-This Trust continues to be known as the "SREE SREE ISWAR DAYA NIDHI" and deemed to have commenced on and from 24th August, 1999.
- REGISTERED OFFICE: The registered office of the Trust shall be situated at Premises No. 87, Ballygunge Place, Kolkata -700019. In future the Registered office may be shifted to another place as the Trustees mutually agree and decide

4. TRUST PROPERTY

The premises herein before mentioned, for the time being representing the same, together with all additions and accretions thereto and contributions and gifts and all accumulated income thereof and all other properties that may be acquired out of the same or become subject matter of the Trust (hereinafter referred to as "the TRUST PROPERTY" and described in the First Schedule hereunder written upon the Trust to be used only for the objects and purposes hereinafter expressed with the power, provisions and/or upon the terms and conditions hereinafter mentioned concerning the same.

5. OBJECTS OF THE TRUST

- (a) To perform Seba Puja of Thakur Sree Sree Iswar Daya Nidhi represented by twin images of Radha Gobinda incarnated in Sree Sree Ram Thakur.
- (b) To worship the said Thakur Sree Sree Iswar Daya Nidhi in the first floor of the First Schedule property in the same manner and at the same place in which the said settler used to perform by offering "Shirni Bhog" in the evening of Seba Puja.
- (c) To perform periodical celebrations of Special Puja of the said Thakur Sree Sree Iswar Daya Nidhi on the occasion of Akshya Trithiya, which is the holy Janmathithi of Sri Sri Ram Thakur and Ratha Yatra in the same manner as the settler used to perform.
- (d) To preserve the gallery of the pictures, photographs, statues and other representations of Gurudev and writings by and on him on the holy relics connected with him in the First Schedule property.
- (e) To make provisions for allotment of suitable portion of the First Schedule property for public congregational prayer to Thakur and for kirtans and bhajan songs; for assembly of public for discourse and discussions; temporary shelter of his bhaktas and admirers.
- (f) To take loans to defend the right of the Thakur, to improve the rights of the Thakur, to develop the properties of the Thakur as per the direction of the Board of Trustees; to make provisions for augmentation of the income of the Thakur, to account for all incomes and accretions from all sources including offerings; to meet the expenses of the Debuttar; to make provisions for savings; to clear the encumbrances and charges; to create reserve fund for the future happenings.
- (g) To carry on the said trust and to manage the Seba Puja and charity in the name of the said Trust and to represent the estate in all matters provided that no

- (h) To start and/or run institutions for the advancement of educational, religious, moral economic and sanitary condition of the public.
- (i) To open, found, build, equip, takeover, conduct and grant aids to dispensaries, maternity homes, hospitals or any other institutions, of the like nature.
- (j) To support and meet the expenses of any Medical School, High School or College for imparting or developing knowledge or training.
- (k) To construct and/or maintain Dharamshalas, temples, parks for the use of the public for cultural and social discourses.
- (l) To grant stipend, scholarships, allowances and monetary aid to indigent Hindu students and scholars.
- (m) To promote education, art, literature, science in general.
- (n) To receive and / or accept any money or other property or asset and to hold the same in such form or manner as may be fit and proper.
- (o) To accept any gift or contribution in cash or in kind and of any property movable or immovable from any person for the objects and purposes of the Trust.
- (p) To meet, discharge and pay all outgoings and expenses of and incidental to the above mentioned objects and for other charity purposes as may deem fit and proper.

6. DUTIES AND POWER OF THE TRUSTEES

The trustees of the said trust shall have the following powers:-

- (a) To take loans in order to clear the charges and encumbrances of the First Schedule property.
- (b) To make provisions for Bhaktas and Followers including shelter in the First Schedule property.
- (c) To provide for Seba Puja as per the direction contained in the said Will.
- (d) To perform periodical celebrations of the Special Puja of the said Thakur Sree Sree Iswar Daya Nidhi on the occasion of Akshya Trithiya, Rath Yatra and others as mentioned in the said Will.
- (e) To apply all the income and accretions from all sources including offerings to the Deities to whom the Debuttar is dedicated and make accounts therefor.
- (f) To meet up all the expenses of the Debuttar and the surplus be kept in a reserve fund to be used for any future happenings.
- (g) To open a Bank Account in any nationalized Bank in terms of the order dated 05.04.2002 passed in connection with Misc Case No. 217 of 2001.

- (h) To enter into development agreement with Developers for development of the First Schedule property or part thereof.
- (i) To deposit the sale proceeds in the said Bank Account after payment of all liabilities of the Debuttar Estate and to invest the sale proceeds (after meeting up all the expenses) of the Trust's allocation in any Branch of State Bank of India and to collect the interest income from the said investment and/or deposits for the purpose of Seba Puja and festivals and for management of the Debutter Estate.
- (j) To execute and register sale deeds in respect of the Trust's allocation and the Developer's allocations in favour of the intending purchasers.
- (k) To take such steps for giving effect of the scheme formulated by the Trust for development of the First Schedule property.
- (1) To invest the Trust properties or the income thereof either in the purchase of or construction of immovable property or for taking on lease or licence immovable property and making construction thereon either by the Trust itself or in co-ownership or in co-partnership or in the purchase of movable properties or in shares, debentures, stocks or other securities, in accordance with any law for the time being in force regarding the powers of the Trustees to invest Trust Funds, or in deposit with any individual firm or company including those in which the Trustees or any of them may be directly interested on such terms and conditions with or without any security as the Trustees may think fit and proper.
 - (m) To sell, alter, vary or transpose or otherwise dispose of or alienate the Trust properties or any investment representing the same, and to reinvest the same in any manner as the Trustee may, in their discretion, think fit and proper.
 - (n) To pay all charges, impositions and other outgoings payable in respect of the Trust properties or any property comprised in the Trust and also to pay all costs of and incidental to the administration and management of the Trust properties for the time being.
 - (o) To sell, dispose of or otherwise transfer any immovable property which may be comprised in the Trust and to invest the sale proceeds thereof in any investment as the Trustees may in their discretion think fit and proper.
 - (p) The Trustees shall be entitled to open and operate savings, current, cash credit, fixed deposit or any other account with any Bank/s and shall be entitled to deposit all sums that may be received on account of and for the

Trust hereof whether as gifts, contribution, interest, dividend or income or otherwise and make withdrawals therefrom and to give instructions to the Bank for transfer and / or re-transfer of any amount and /or interest from one account to the other.

(q) Any Trustee can, with the approval of the other Trustees, nominate or appoint Constituted Attorneys or Agents and to delegate to such Constituted Attorney or Agent all such duties and/or powers as may be necessary to implement and carry out and/or to execute documents in accordance with the decision of the Trustees and from time to time remove such attorney or agent and reappoint other in his or their place.

7. DUTIES OF THE TRUSTEES:

- a. The Trustees shall be chargeable only for moneys, stocks, shares and funds that shall actually come into their hands and shall not be answerable or accountable for neglect, default acts of omission or commission of the other Trustees nor of any Bankers or other persons with whom the other Trustees properties of any securities may have been deposited or handed over unless caused by their willful neglect or default.
- b. All the Trustees shall be bound to maintain and defend all such suits and (subjects to provision of this deed) to take such other steps as may be reasonable requisite for the preservation of the Trust property and the assertion or protection of the title.
- c. The Trustees shall be bound to deal with the Trust property as carefully as a man of ordinary prudence to deal with such property as if it were their own and in the absence of a contract to the contrary, a Trustee so dealing shall not be responsible for the loss, destruction or deterioration of the Trust property.
- d. If the Trustee shall commit or threatens to commit any act which shall be destructive or permanently injurious to the Trust property, the remaining Trustees shall be bound to take measures to prevent such act.
- e. The Trustees shall be bound to keep clean and accurate accounts of the Trust property at all reasonable times.

8. INDEMNITY TO TRUSTEES ETC.

The Trustees for the time being of these present shall be chargeable for only such moneys stocks, funds, deposits and securities they shall actually receive notwithstanding their signing of any receipt, defaults and not for those of each other or of any baker, auctioneer or any other person with whom and into whose hands any Trust money of securities may be deposited or come in accordance with these presents nor for the deterioration or loss of any stock,

funds, deposits, or securities nor any other loss the same shall happen through their own willful default.

9. APPOINTMENT RETIREMENT AND REMOVAL OF TRUSTEES

- i) Any of the Trustees may resign from the office of Trustee on giving one month's notice, in writing, to the Managing Trustee.
- ii) If any Trustee dies or resigns or becomes incapable or unfit to act, the Managing Trustee shall be entitled to appoint a successor in place of the Trustee(s) dying or retiring or becoming incapable or unfit to act.
- iii) Upon the appointment of a new Trustee or Trustees, the Trust properties shall vest in the new Trustee or Trustees jointly with the continuing or surviving Trustees with the powers, provisions and subject to the Trust hereby created.

10 MEETINGS AND PROCEEDINGS OF THE TRUST

- i) The Trustees are authorised to carry on the administration of the Trust in the manner they may consider best, and for the administration of the Trust, including the purpose or policy thereof, they may frame schemes, rules and regulations and may decide the same from time to time as deemed fit PROVIDED HOWEVER such scheme, rules and object shall not contravene any of the provisions of the said WILL.
- ii) The Trustees of the TRUST shall meet at 87, Ballygunge Place for the purpose of transacting the business of the Trust.
- iii) The Trust shall hold at least one meeting in every three months interval.
- iv) Managing Trustee may call any emergency meeting of the Board of Trustees by giving each Trustee one week's notice or such shorter notice as the Trustees may decide from time to time.
- Any resolution signed by a majority of the attending Trustees, shall be as good as passed in a meeting of the Board of Trustees.
- It will be the endeavor of the trustees to take all decisions unanimously. However, in the case of any difference of opinion amongst the Trustees, the opinion of the majority shall prevail.

11. FUNCTION OF TRUST

- a. The Managing Trustee shall be authorized to open Bank account in the name of the Trust in any Nationalized Bank or any other scheduled Bank in the country.
- b. The Bank Account of the Trust shall be operated by the Managing Trustee and any one of the Trustees, as may be resolved from time to time in the Trust Meeting.

- c. The Managing Trustee shall be authorized to apply for Permanent Account Number (PAN) before the appropriate authority in the name of the Trust.
- d. The Managing Trustee shall be authorized to obtain all licenses and/or permission, if necessary, for functioning of the TRUST.

12. OTHER PROVISIONS

- a. Subject to provision of the law, any moneys to be invested hereunder, shall in the absolute discretion of the Trustee (and they shall not be liable to answer for the exercise of such discretion) be invested in such manner as may be decided by the Trustees and such investment shall be according to the requirements and provisions of Income Tax Act, 1961 or any modification thereof from time to time and the Trustees shall have the unrestricted powers of varying and/or transposing the investment in their absolute discretion.
- b. Where the Trustees in the purported exercise of the Trusts discretion and powers hereby or by law conferred act on the advice of any Counsel, Solicitor, or other Lawyer, engineer, Surveyor, Land and Estate Agent, Actury Broker, Cashier, Accountant, or expert, the Trustees shall not be responsible for any loss that may result from action on such advice but the act or omission shall be deemed to be authorized and proper and the advice shall operate to protect the trustees in the like manner as if the act or omission has been directed or authorized under an Order of a Court of Competent Jurisdiction.
- c. Notwithstanding anything herein contained the income as also the corpus of the trust fund shall be applicable and be applied to or for public charitable purposes only within such territories and subject to such conditions or limitations, if any, as may from time to time be laid down in the Income Tax Act, 1961 or any other Act or Acts governing taxation of Income and wealth of public charitable trust so as to render the trust hereby established as well as its income eligible for exemption from taxation under such Acts now prevailing or any modification or reenactment thereof.
- d. The Trust hereby established shall always retain the status of the one to which the provisions of Section 80G of the Income Tax, 1961 or any modification, replacement or re-enactment thereof for the time being in force shall apply so that any donation or contribution thereto is recognized as eligible for exemption or relief from Tax in the hands of the donor.

13. AMENDMENTS:

(a) While this Trust shall be irrevocable, the Board of Trustees may amend any of the clauses except those relating to objects of the Trust.
