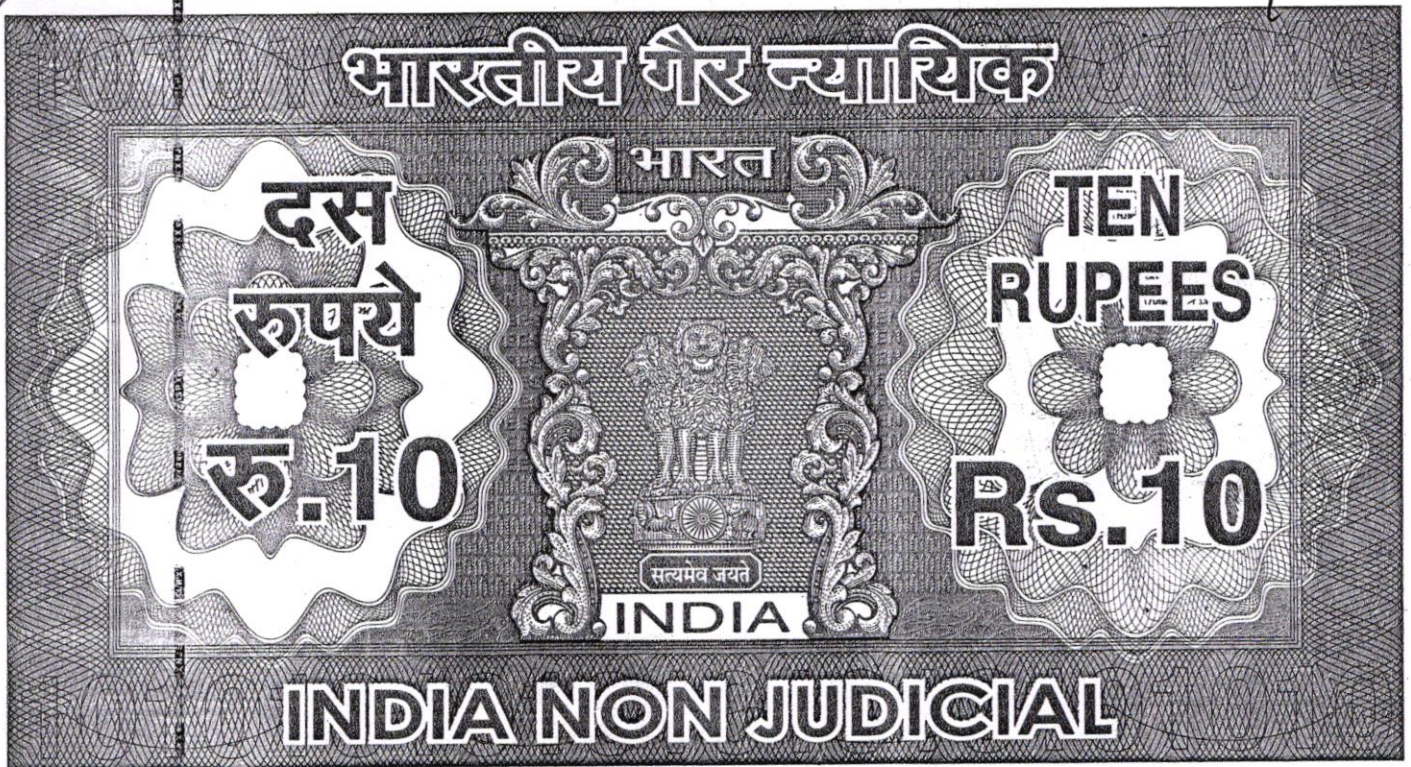

Plot Nos. 9(P) and 10(P), of Mouza : Bademasur, J.L. No. 31, Sub-Registry Office at Alipore, Police Station – Jadavpur, within limits of the Kolkata Municipal Corporation Ward No. 102, being the K.M.C. Premises No. 30, Baghajatin Block 'D', Assessee No. 31-102-02-0030-7, postal address D/31, Baghajatin, P.O. Jadavpur University, Kolkata – 700032, District : South 24-Parganas, by Deed of Gift dated 17/11/1988 gifted by the Governor of the State of West Bengal, which deed was registered in the Office of the Additional District Registrar at Alipore, South 24-Parganas and recorded in Book No. I, Volume No. 47, Pages 257 to 260, being No. 3515, for the year 1988.


