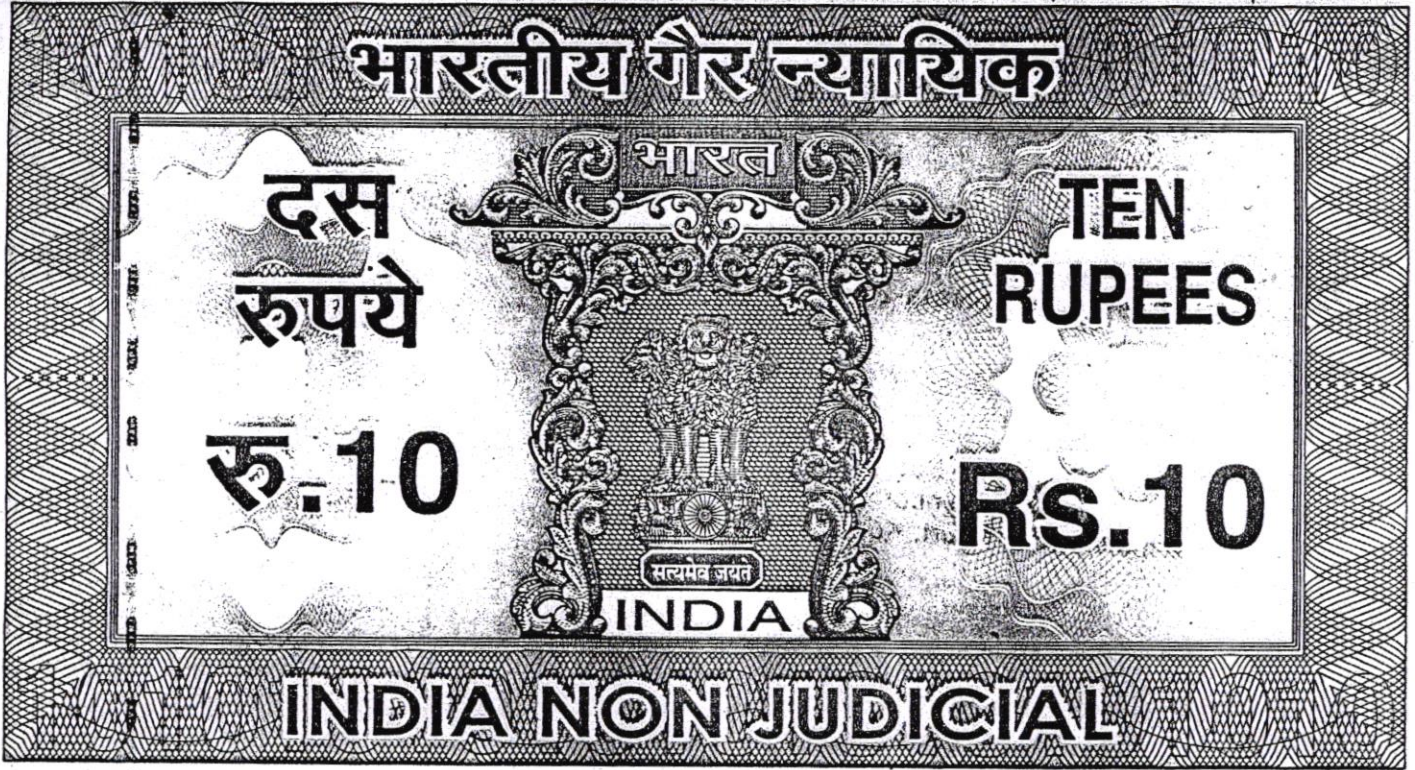

THE KOLKATA MUNICIPAL CORPORATION (K.M.C.), a corporate body constituted under the West Bengal Act, LIX of 1980, having its central office at 5, Surendra Nath Banerjee Road, P.O. - Dharmatala, P.S. - Taltola, Kolkata - 700013, hereinafter called and referred to as the **DONEE** (which term or expression shall unless excluded by or repugnant to the subject or context be deemed to mean and include its executors, administrators, representatives, successors-in-interest, successors-in-office and assigns) of the **OTHER PART**.

AND WHEREAS the said proposal or offer of the DONOR has been accepted by the Kolkata Municipal Corporation, the DONEE herein, and it has been decided interalia that the said Gift of strip of land measuring about 39.988 Sq.M. more or less on the Western portion of said Premises for sanction of the building plan in respect of the K.M.C. 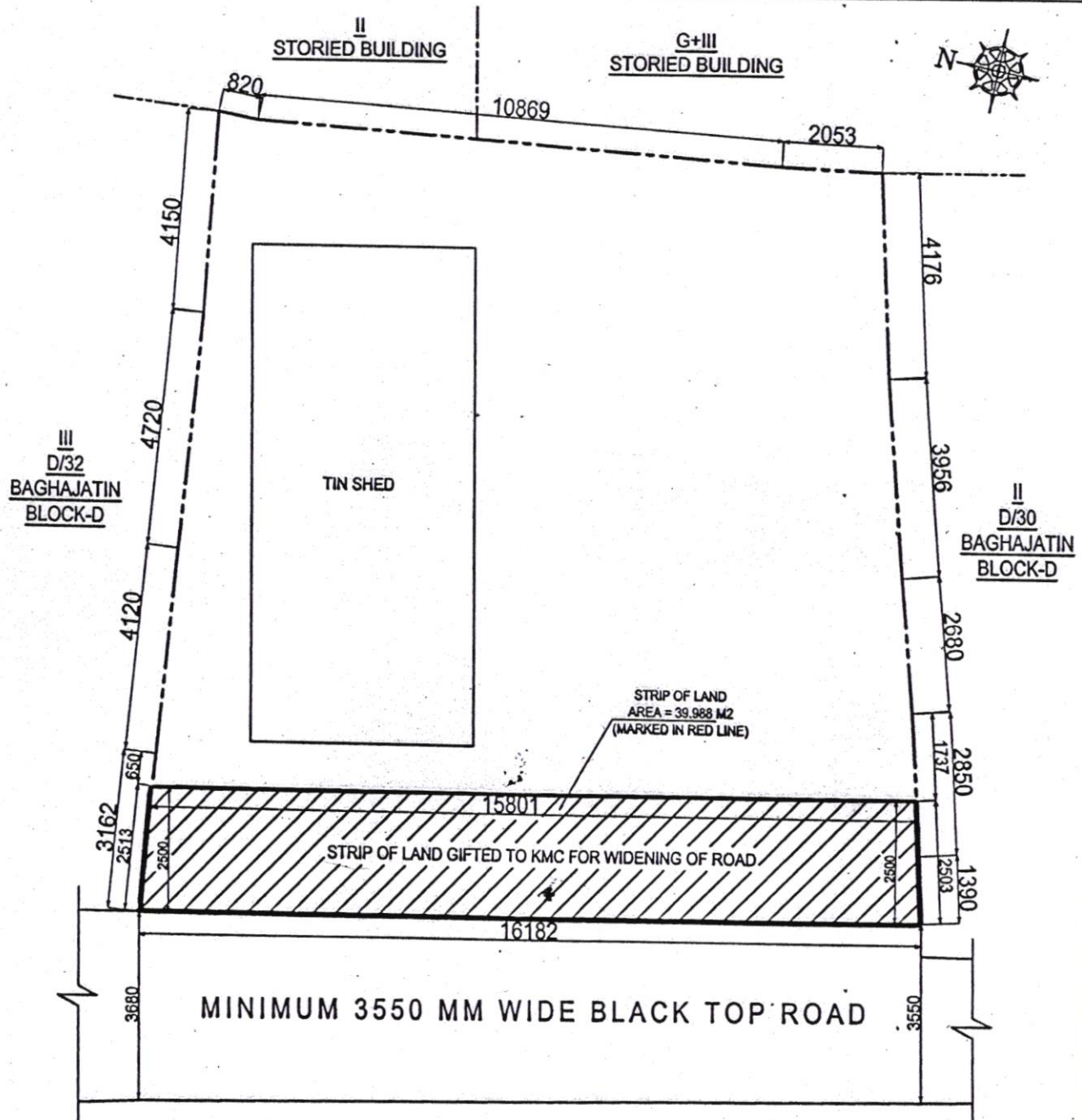
