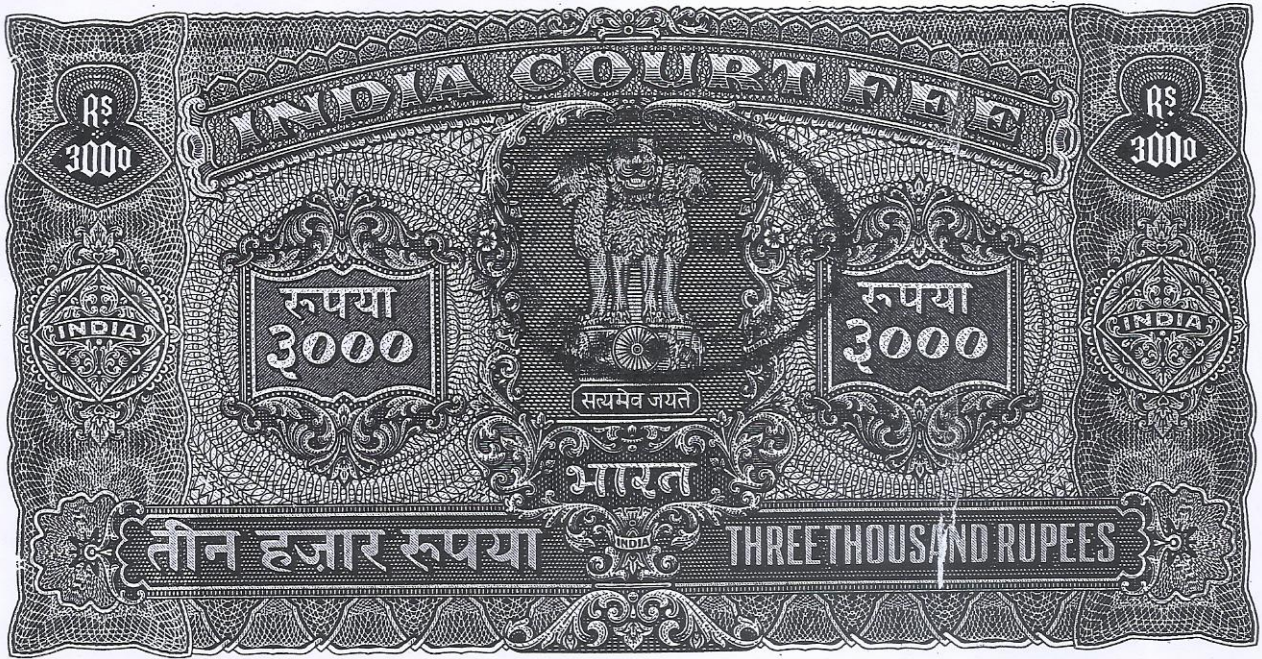

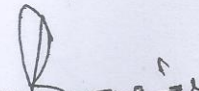

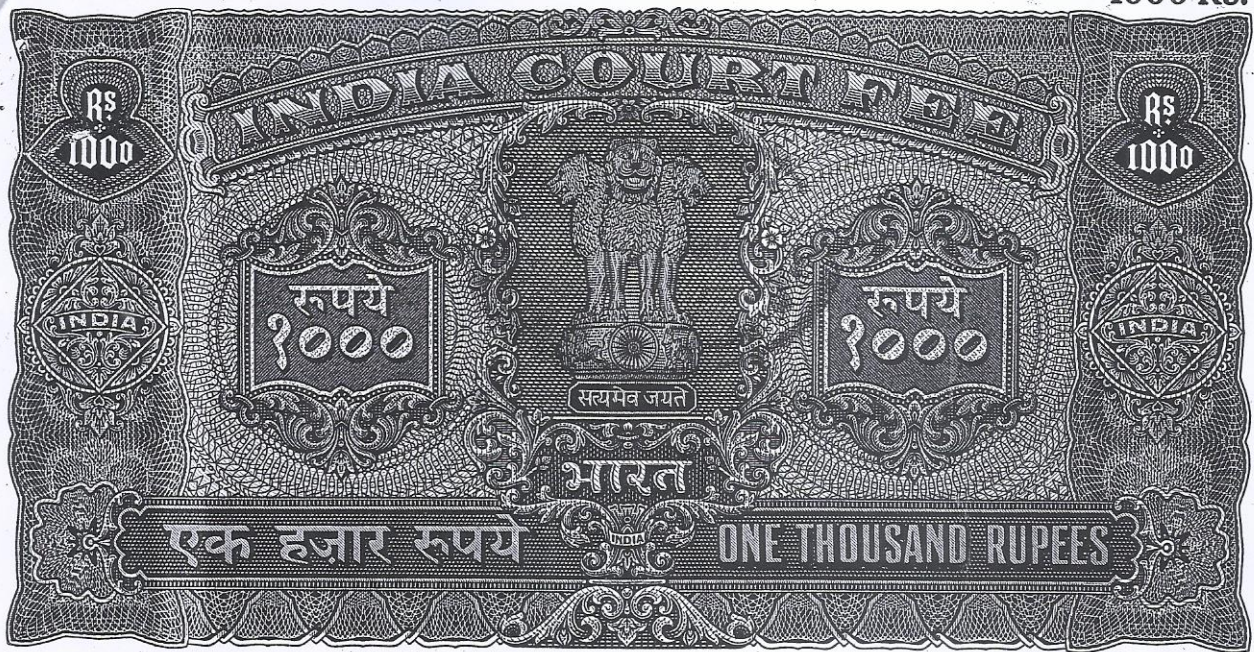

WHEREAS I am now 78 years old and have been keeping indifferent health for a past few months.
