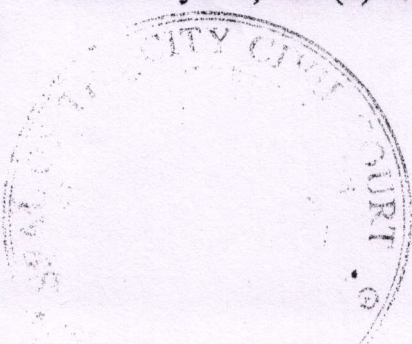
I accordingly declare them as the sole beneficiary (s) and universal legatee of my this **WILL**.

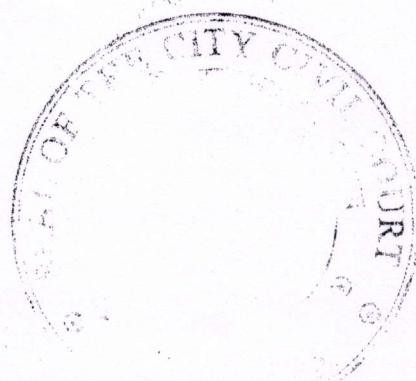

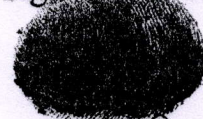
