If, however, the completion of the Project is delayed due to the Force Majeure condition then the Allottee agrees that the Promoter shall be entitled to the extension of time for delivery of possession of the [Apartment/Plot], provided that such Force Majeure conditions are not of a nature which make it impossible for the contract to be implemented. 7.2 Procedure for taking possession – The Promoter, upon obtaining the occupancy certificate\* from the competent authority, shall offer in writing the possession of the [Apartment/Plot], to the Allottee in terms of this Agreement to be taken within 03 (Three months from the date of issue of such notice and the Promoter shall give possession of the [Apartment/Plot], to the Alottee. The Promoter agrees and undertakes to indemnify the Alottee in case of failure of fulfillment of any of the provisions, formalities, documentation on part of the Promoter. The Alottee agree(s) to pay the maintenance charges as determined by the Promoter / Association of Allottees, as the case may be. The Promoter on its behalf shall offer the possession to the Allottee in writing within \_\_\_\_\_\_ days of receiving the occupancy certificate\* of the Project.

7.3 Failure of Allottee to take Possession of [Apartment/Plot] – Upon receiving a written intimation from the Promoter as per Clause 7.2, the Allottee shall take possession of the [Apartment/Plot] from the Promoter by executing necessary indemnities, undertakings and such other documentation as prescribed in this Agreement, and the Promoter shall give possession of the [Apartment/Plot] to the allottee. 7.5 Cancellation by Allottee: The Allottee shall have the right to cancel/withdraw his allotment in the Project as provided in the Act.
