- NAME: The name and style of the firm of partnership shall be **B.D.**CONSTRUCTION. The partners shall be entitled to carry on business under any other name and/or names as may be agreed upon mutually from time to time.
- O2) COMMENCEMENT: The Partnership firm shall be deemed to have commenced business on and from 19th day of April, 2023
- 03) BUSINESS: The partnership business shall be in the line of Builder and Developer for construction of Building and or any other business if they desire from time to time.
- PLACE: The partnership business shall be carried on at Laskarpur Peyarabagan, P.O. Laskarpur, P.S. Sonarpur now Narendrapur, Kolkata-700 153, District: South 24-Parganas and/or any other place as mutually agreed upon from time to time.
- O5) **DURATION**: The duration of the partnership shall be 'AT WILL' but in case any partner desires to retire from the partnership he shall be at liberty to do so by giving six month's notice in writing to the another partner. On
