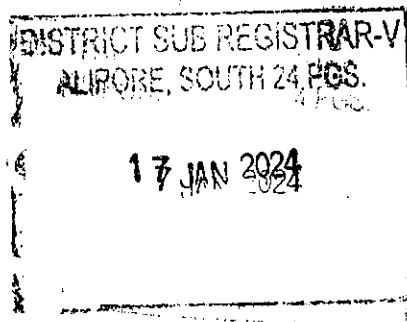

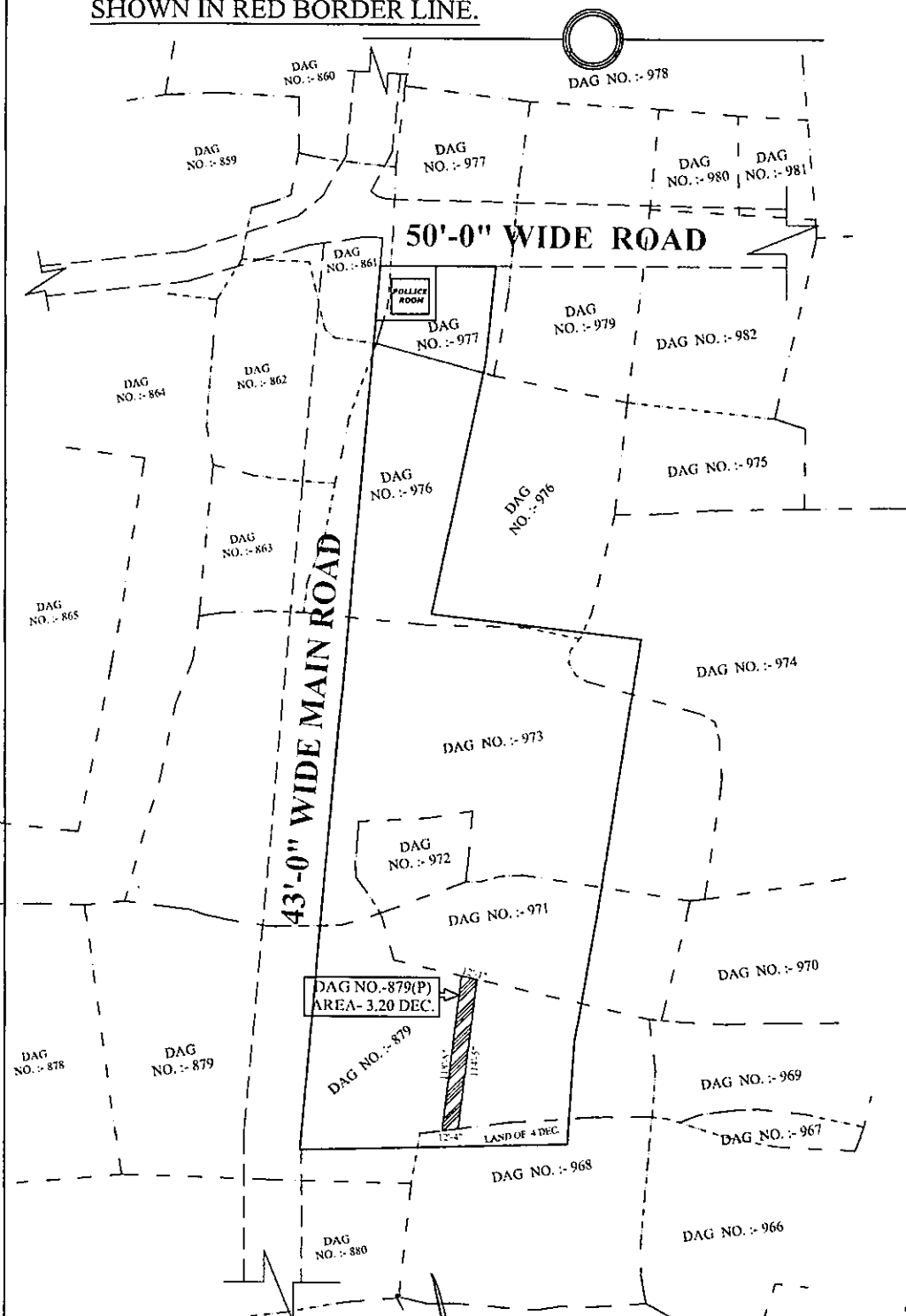
SITE PLAN

DIST. - SOUTH 24 PARGANAS; UNDER BEONTA II GRAM PANCHAYET.

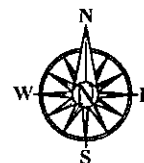
