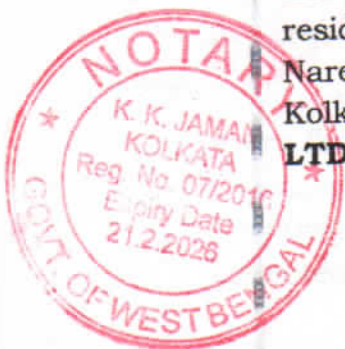

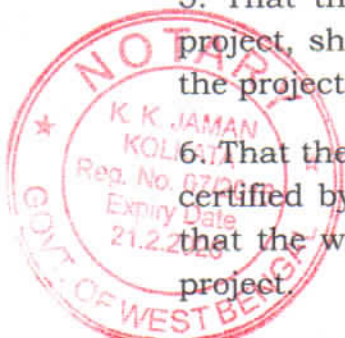
3. That the time period within which the project shall be completed by us is 21/12/2025
