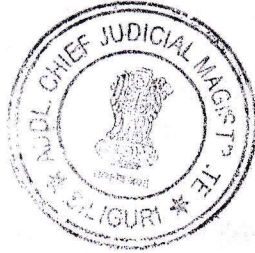

AFFIDAVIT

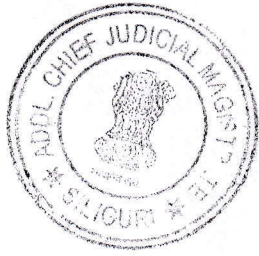
