1. That, DEBU MAL, JAYANTI MAL Landowner has a legal title to the land on which the development of the project is to be carried out.

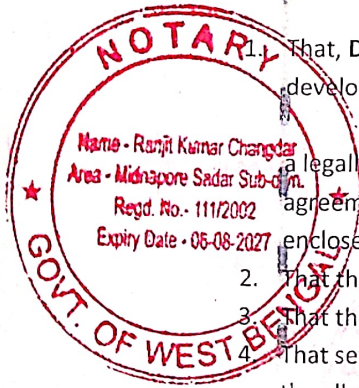

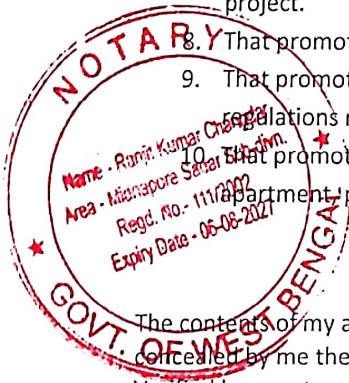

5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.

7.
