

- I, SIBASISH CHATTERJEE, duly authorized by the Promoter/Developer of the proposed project do hereby solemnly declare, undertake and state as under:
- 1. That the Promoter/Developer has the legal title to the land on which the development of the project is proposed AND a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and Promoter/Developer for development of the Real Estate project is enclosed herewith.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by the Promoter/Developer is 30.06.2027.
- 4. That seventy percent of the amounts realised by the Promoter/Developer for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for the purpose.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
- 6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect, and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

That Promoter/Developer shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of the completion of the project.
- 8. That the Promoter/Developer shall take all the pending approvals on time, from the competent authorities.

That the Promoter/Developer have furnished such other documents as have been prescribed by the titles and regulations made under the Act.
