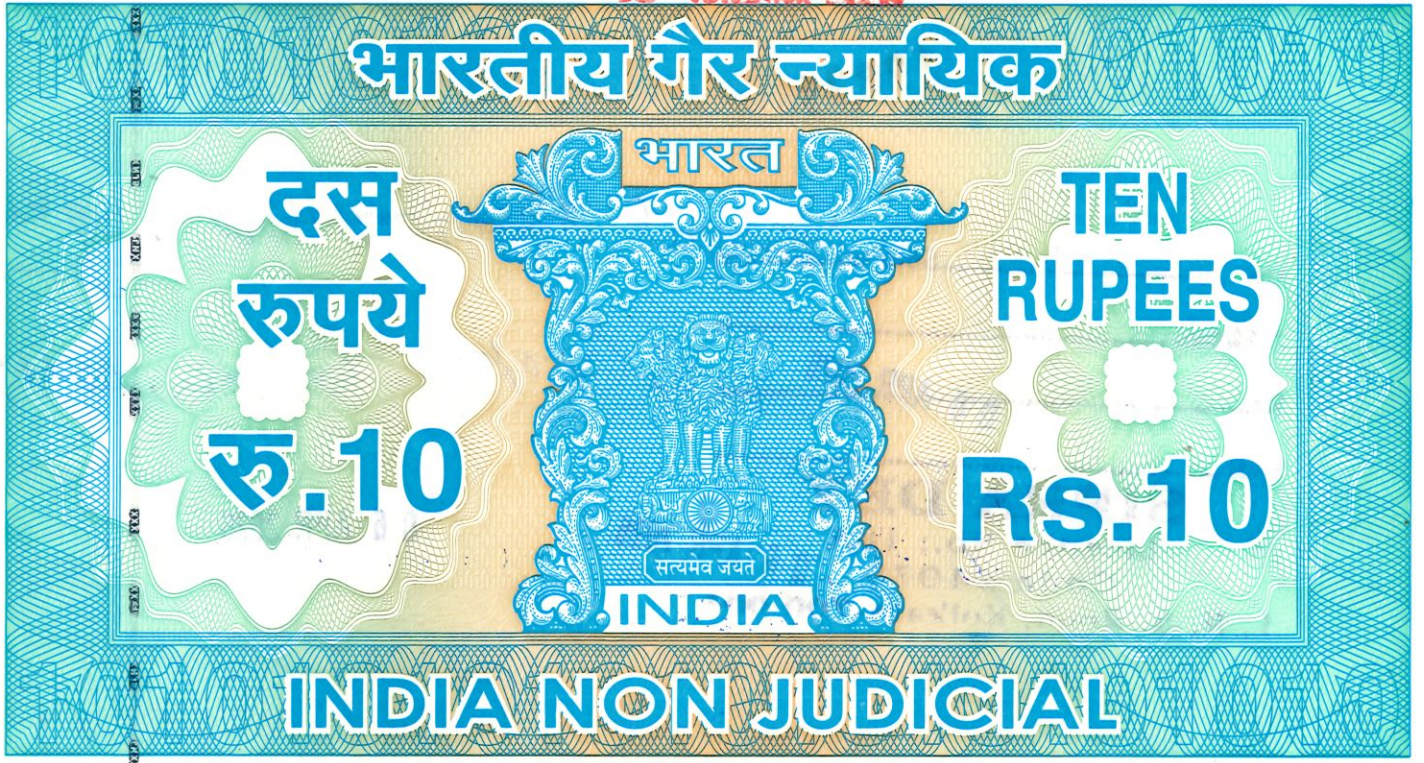
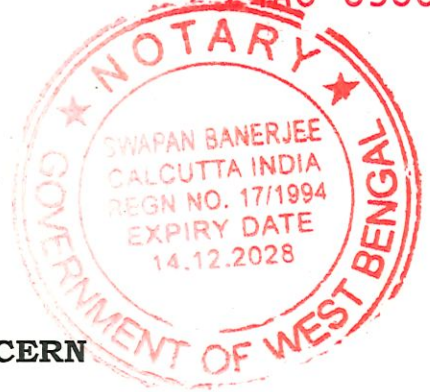

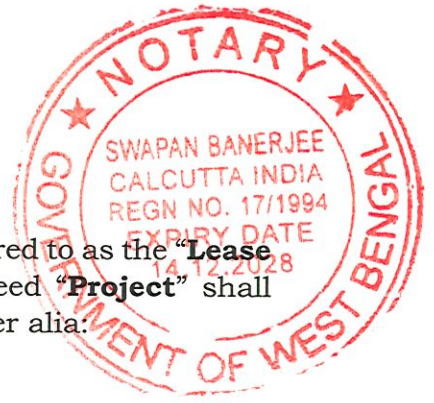

1. That in terms of the Lease Deed executed on 21st January, 2010, between West Bengal Industrial Development Corporation Limited and Bengal Aerotropolis Projects Limited, bearing No. 00852 for the year 2010, Registered in Book - I, CD Volume No. 2, Pages 3728 to 3866, registered

under A.R.A – III, Kolkata, West Bengal (hereinafter referred to as the **"Lease Deed"**), as per the definition Clause 1 of the Lease Deed **"Project"** shall mean the proposed Aerotropolis projects comprising inter alia:

- a) An Airport;
- b) An IT & Industry Park;
- c) An Institutional Area;
- d) A Township; and
- e) A Rehabilitation & EWS Zone.

2. It has been further clarify that as per the definition clause 1 of the Lease Deed the different zone comprised as follows:

- **"Airport"**, and land specify for the Airport as "Airport Land";
- **"Institutional Area"** comprised of commercial and retail and similar establishment;
- **"IT & Industrial Park"** comprised of modern industries;
- **"Rehabilitation & EWS Zone"** comprised of rehabilitation;
- **"Township"** comprised of residential units and housing for all income groups.

3. It is hereby declared that Clause 18 (**"Events of Default and Termination"**) of the said Lease Deed is not applicable to the present project namely "AAROHI 2.0, PHASE - II", as the said project is situated entirely within the "Township" zone, as defined under Clause 1 of the Lease Deed. The conditions set forth in the termination clause apply specifically to the "Airport Land", "IT & Industrial Park" and "Rehabilitation & EWS Zone". The provisions of Clause 18 does not extend to individual residential developments located within the designated Township zone.
