



I, Nagendranath Basu of 170/B/217 Lake Gardens, Calcutta-45, hereby revoke all testamentary dispositions heretofore made by me, and declare this to be my last Will, which I make this Twenty Second day of December 1971.

Subject to the payment of my funeral and testamentary expenses and debts, which, with all duties, shall be paid primarily out of my personal assets, I hereby give devise and bequeath all my movable assets, namely, Fixed Deposits, balances in Current Accounts and Savings Bank Accounts with different banks, 15 year and 10 year Cumulative Time Deposits with Lake Gardens Post Office, Fixed Deposits with Indian Iron and Steel Co. Ltd., and East India Hotels Ltd., National Savings Certificates with Dharamtala Post Office, Preference and ordinary shares of different companies held by me, 10 year Annuity Deposits with Reserve Bank of India (including any assets which I may hereafter acquire and/or otherwise die seized and possessed of) to my wife Srimati Sudha Basu at present residing at 170/B/217 Lake Gardens, Calcutta-45 absolutely and I hereby give devise and bequeath all my immovable properties and assets, namely, premises No.170/B/217 Lake Gardens, (previous No.170/1A Prince Anwar Shah Road) Calcutta-45 and No.170/B/218 Lake Gardens (previous No.170/10 Prince Anwar Shah Road) Calcutta-45 (including any immovable property or asset which I may hereafter acquire and/or otherwise die seized and possessed of) to my nephew Sriman Tejomoy Basu at present residing at 170/B/217 Lake Gardens, Calcutta-45 subject to the condition that my wife Srimati Sudha Basu shall
