

1. That PRODIP KUMAR BASAK, ANITA BASAK, MANIKA BASAK, SANKAR BASAK, and MANASH KUMAR BASAK have the legal title to the land on which the development of the proposed project is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
  2. That the said land is free from all encumbrances.

  4.
