AND whereas the Government of West Bengal (hereinafter referred to as the "Government") offered all reasonable facilities to such persons (hereinafter referred to as "Refugees") for residence in West Bengal.

AND whereas a considerable number of such people were compelled by circumstances to use vacant lands in the urban areas for homestead purposes.

AND whereas the DONEE was one of such persons who had come to use and occupy a piece of land particuarly described in the schedule hereunder.

AND whereas the DONEE being a refugee displaced from East Pakistan (now Bangladesh) approached the Government of West Bengal for a plot of land for his rehabilitation.


AND whereas it has been decided by the Government to make a gift of the said plot of land in favour of the DONEE so as to confer absolute right title and interest in the said land where he has been residing peacefully for a long time more fully described in the schedule hereunder written.


NOW THIS DEED WITNESSETH that in consideration of the premises bereinbefore mentioned and to provide relief to the DONEE in consideration of his/her destitute condition the DONOR doth hereby absolutely give grant and transfer unto the DONEE ALL THAT PIECE AND PARCEL OF LAND more fully described in the schedule hereunder written as homestead land OR HOWSOEVER otherwise the said land hereditaments and premises are or is at any time or times heretofore were situated butted bounded as hereinafter described TOCETHER WITH all ways, paths, passages, easements, privileges, appendages and appurtenances whatsoever with all-easements therete and therein TO HAVE AND TO HOLD THE SAID land here litaments and premises hereby given granted and transferred unto and to the use of the DONEE forever AND the DONEE shall and may at all times hereafter peacebly and quietly possess and enjoy the said land hereby given granted and transferred subject to the condition that the DONEE shall have no right save as hareinafter provided to alienate or transfer in any way the land comprised in the schedule hereunder written in any manner whatsoever within a period of 10 (ten) years from the date these presents without obtaining prior written permission of the DONOR which shall not be obligatory on the part of the DONOR to give and which will be granted only in exceptional circumstances of hardship PROVIDED THAT THE DONEE shall be at liberty to mortgage, charge or encumber the said land with a the Life Insurance Corporation of India or any Nationalised or Scheduled Bank, Co-operative Bank or Givern ment or any Statutory Body or Government Sponsored Financial Institution within this period of ten years for the purpose of construction of a residential building therein and for the purpose of better economic and physical. improvement, A D THE DONOR and all persons lawfully and equitably claiming as a foresaid shall an from time to time and at all times hereinafter at the request and costs of the DONEE do or exe or cause to be done and executed all such acts deeds and things whatsoever for further better and me perfectly assuring the said messuage land hereditaments and premises and every part thereof unto the DONEE in the manner aforesaid as shall or may be reasonably required.

To Stree, And no. Barn. Sto. Lake Rhicharon Barn.	
The Government of West Bengal has acquired the land comprised in the squatters' colony at police-station, which is now in the occupation of refugees living in the said colony. Government is agreeable to regularise the possession of the occupants. Since you are now occupying a portion of the aforesaid land, plot No. 1/3 in the survey map of the said colony as prepared by the Refugee Relief and Rehabilitation Department may be allotted to you provided you agree to the following terms and conditions, namely:—	
1. That you should pay to the Government of West Bengal (hereinafter referred to as the "Government") the value of the said plot of land to be allotted to you including the proportionate value of the land required for providing roads, passages, open spaces, etc., in the colony at a rate to be determined by the Government and that you should pay such sum within such period as may be fixed by the Government for the purpose in manner hereinafter mentioned in clause 4 hereof.	
That you shall occupy only the plot of land measuring 2‡ cottahs as	

- shown in the said departmental survey map which will be allotted to you.
- 3. Should you desire to souppy of be found to be occupying any area in excess of 21 cottahs you shall pay to the Government the value of the excess land as determined by Government at such rate as may be fixed by the Government in accordance with the provisions of clause 4 hereof.
- 4. Out of the amount that shall be payable by you under the provisions of clauses 1 and 3 hereof Rs. 1,875 will be payable by you in such instalments and within such times as may be fixed by th Government and you shall execute and register a Bond in respect of the same embodying such terms, conditions and covenants as may be decided by the Govrnment. You will pay the amount in excess of the said sum of Rs. 1,875 n cash to the Government within such time as may be fixed by the Government.
- 5. That you shall not, in any even, occupy any land comer than what is allotted to you under clauses 2 and 3 and nall give up any land otherwise occupied by you immediately on being called upon by the Government & do so.
