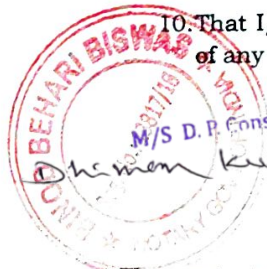
1. That (1) **SRI BISWAJIT SINHA ROY**, (2) **SMT.KAJAL SEN GUPTA**, (3) **SMT. NILANJANA SEN GUPTA** and (4) **SRI NIRMESH SEN GUPTA** have a legal title to the land on which the development of the proposed project is to be carried out
