No. 3, Police Station Airport, within Ward No. 4 of Rajarhat-Gopalpur Municipality, lying, situates and being Municipal Premises No. RGM8/15, BL-G, N-08, District North 24 Parganas (Said Property) morefully described in the Schedule below together with all title, benefits, easement, authorities, claims, demands, usufructs, tangible and intangible rights of whatsoever or howsoever nature of the Vendor in the Said Property and appurtenances and inheritances for access and user thereof, free from all encumbrances.
5. Background, Representations, Warranties and Covenants

- 5.1.3 **Correction in Purchase Deed:** Owing to some error the said purchase deed of Chapabala Sardar required rectification and thus, the said purchase deed was duly rectified by a Deed of Declaration dated 22<sup>nd</sup> September, 1970. And thus, by virtue of the aforesaid purchase Chapabala Sardar became the absolute owner of the Said Property.
- 5.1.4 **Devolution of Title:** After the demise of Chapabala Sardar, the Said Property devolved into Mrs. Bapi Mondal by virtue of inheritance. And thus Mrs. Bapi Mondal became the owner of the Said Property.
- 5.1.5 **Sale to Niranjn Roy:** By a Deed of Conveyance dated 25<sup>th</sup> November, 1985, registered in the Office of the Additional District Sub-Registrar, Bidhannagar, in Book No. I, Volume No. F-154, at Pages 369 to 376, being Deed No. 8194, Mrs. Bapi Mondal sold the entirety of the Said Property, to Niranjn Roy.
- 5.1.6 **Sale to Vendor:** By a Deed of Conveyance dated 13<sup>th</sup> December, 1990, registered in the Office of the Additional District Sub-Registrar, Bidhannagar, in Book No. I, Volume No. 29, at Pages 359 to 364, being Deed No. 1588 for the year 1991, Niranjn Roy sold the entirety of the Said Property, to the Vendor.
- 5.1.7 **Records of Rights:** The Vendor mutated her name in the records of Block Land and Land Reform office vide L.R. *Khatian* No. 472 and also in the records of Rajarhat-Gopalpur Municipality.
- 5.1.7 **Absolute Ownership:** Thus, by virtue of aforesaid purchase and record the Vendor has become the absolute owner of the Said Property.
- 5.2 **Representations, Warranties and Covenants Regarding Encumbrances:** The Vendor represents, warrants and covenants regarding encumbrances as follows:

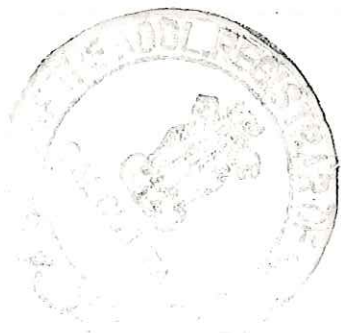

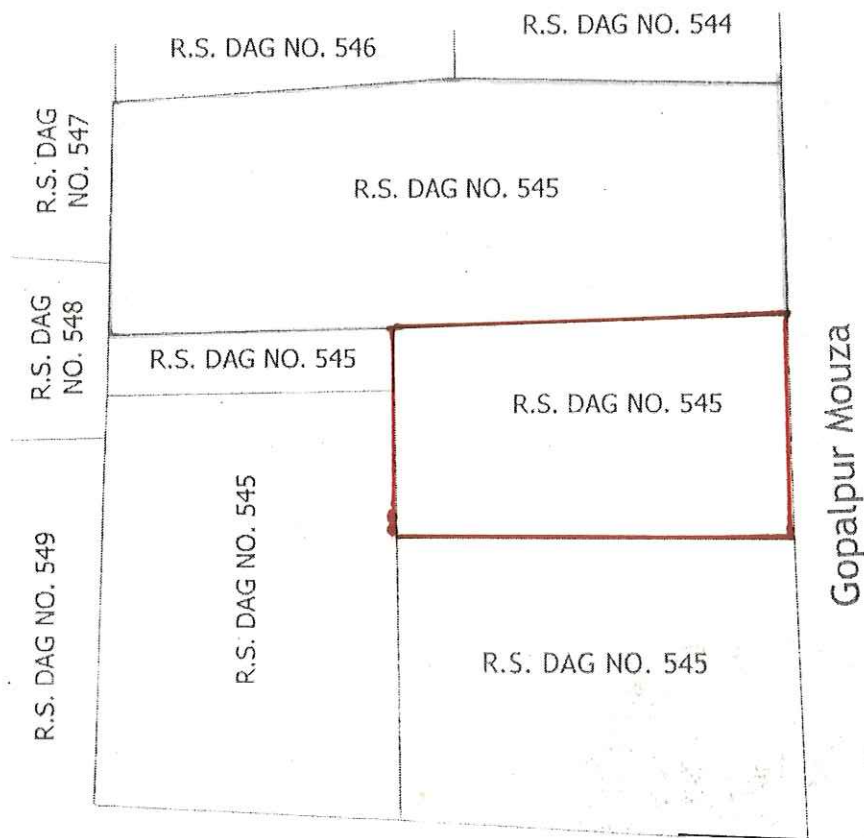

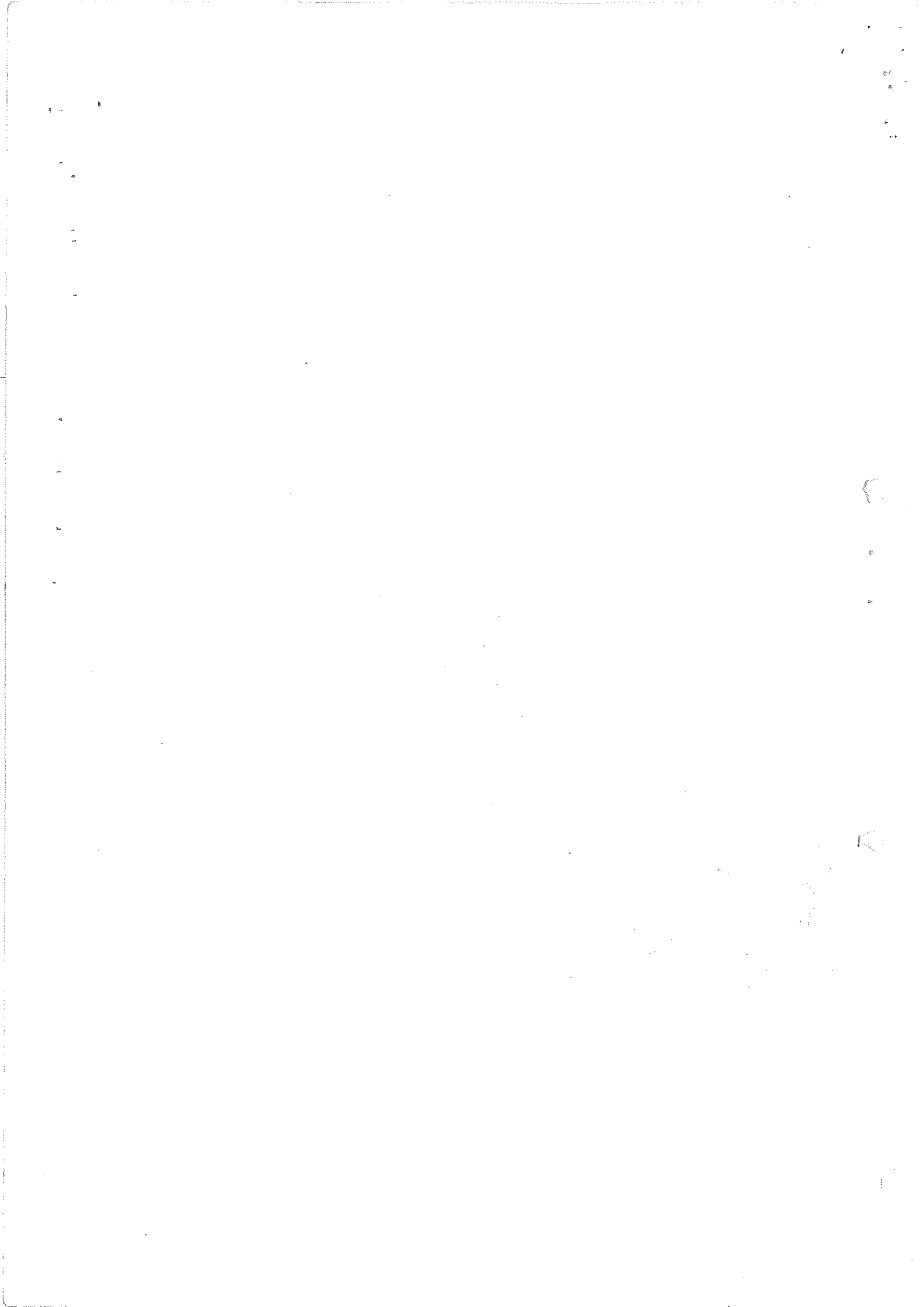
