AFFIDAVIT



5. That my father died intestate on 22/05/2010 leaving behind his wife namely Khelu Palit and six daughters namely 1) Dolly Mitra (2) Tarulata Kar (3) Alpana Dey (4) Sweta Nandy (5) Suparna Dey nee Suparna Palit (6) Aparna Palit as his legal heirs and successors.
6. That Khelu Palit, wife of Jitendra Bhusan Palit died intestate on 22/05/2010 leaving behind her six daughters namely 1) Dolly Mitra (2) Tarulata Kar (3) Alpana Dey (4) Sweta Nandy (5) Suparna Dey nee Suparna Palit (6) Aparna Palit as her legal heirs and successors
7. That I along with other co sharer of the aforesaid property have amalgamated the two plots.

That since then I along with other co sharer of the aforesaid property approach the BL and LRO to mutate our name in their record but the concerned department verbally intimate us that they do not have any such instruction / notification to mutate the land in private name which are recorded in the name of Refugee Relief Rehabilitation Department.
