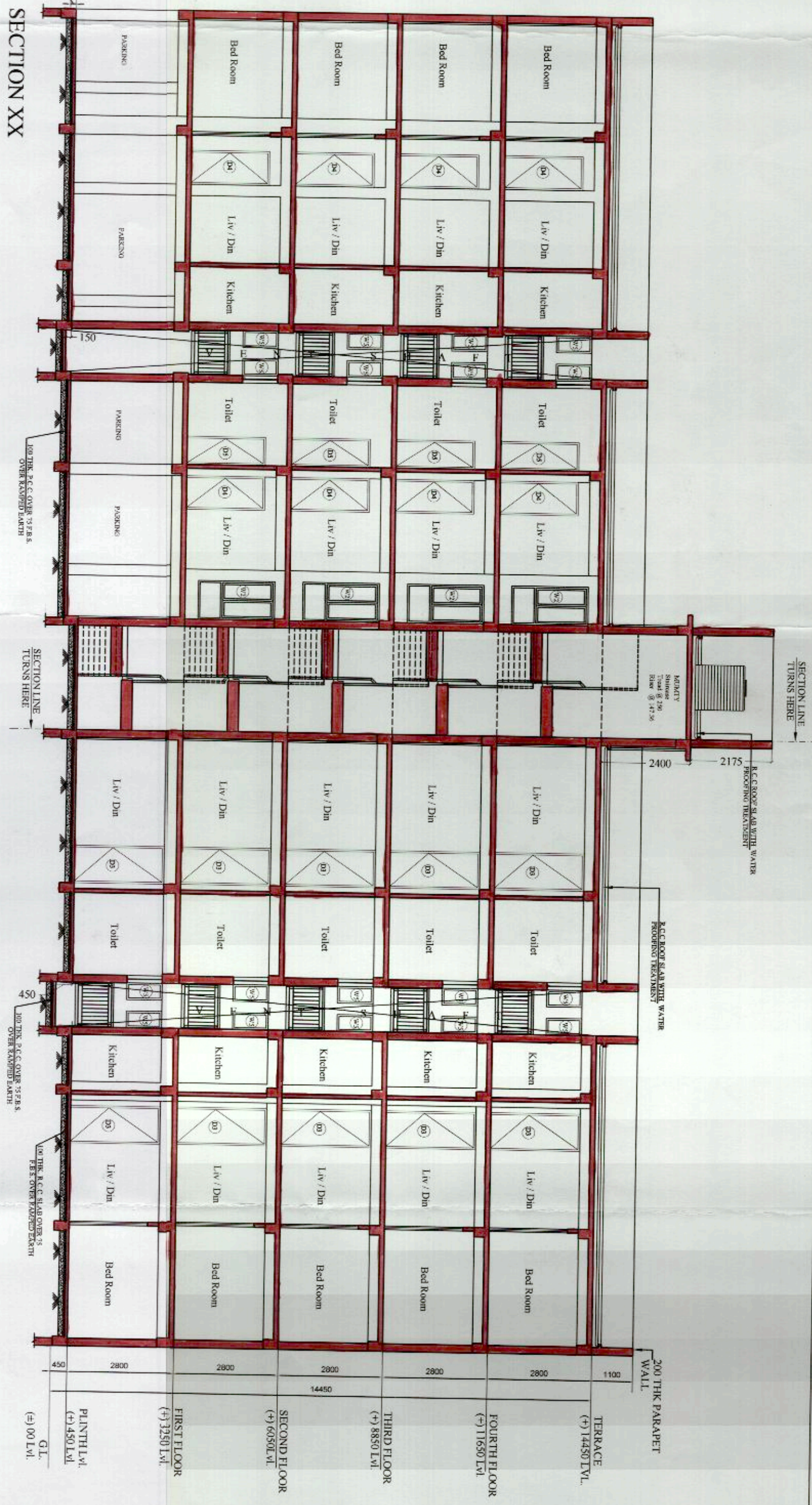
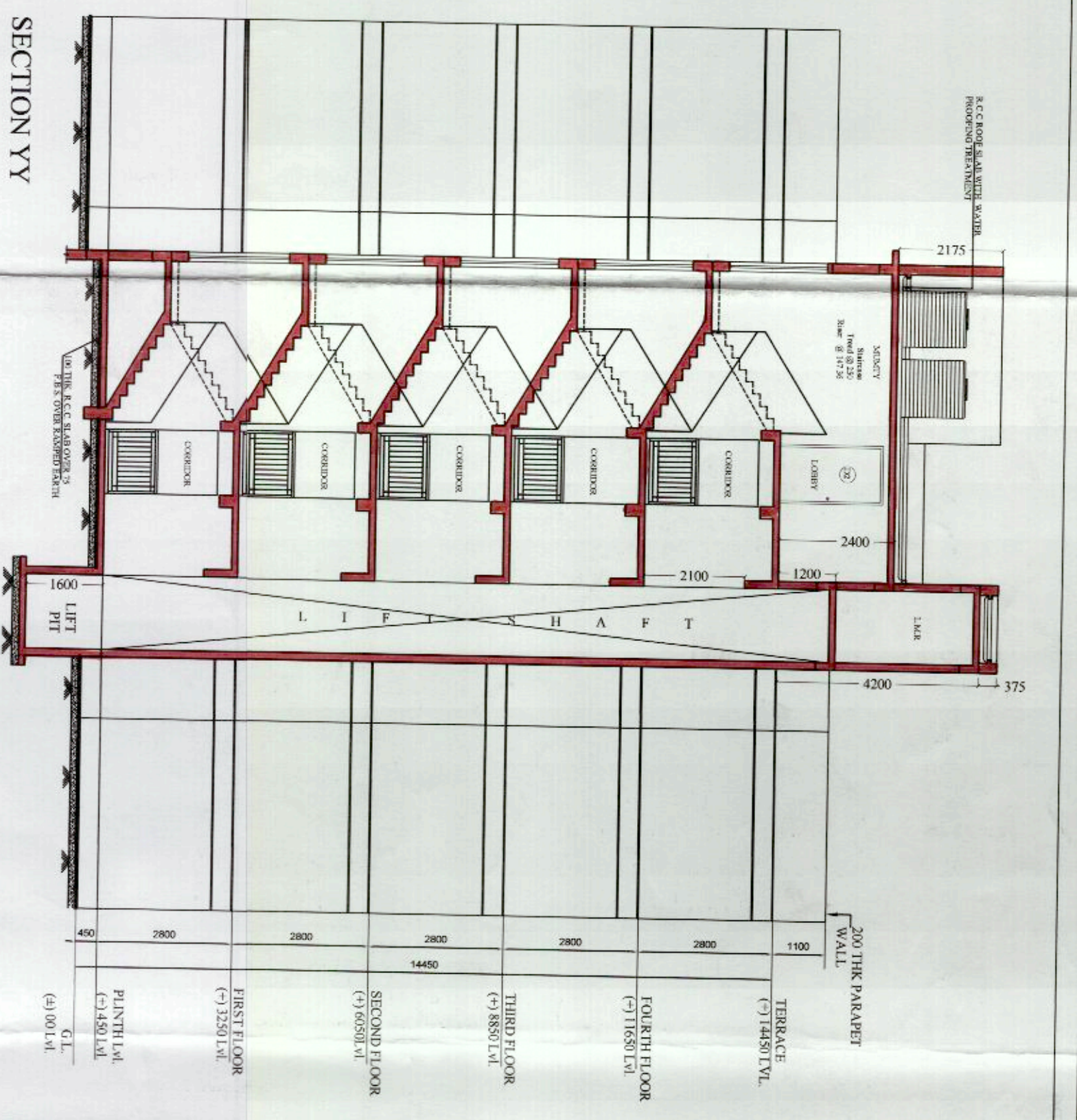


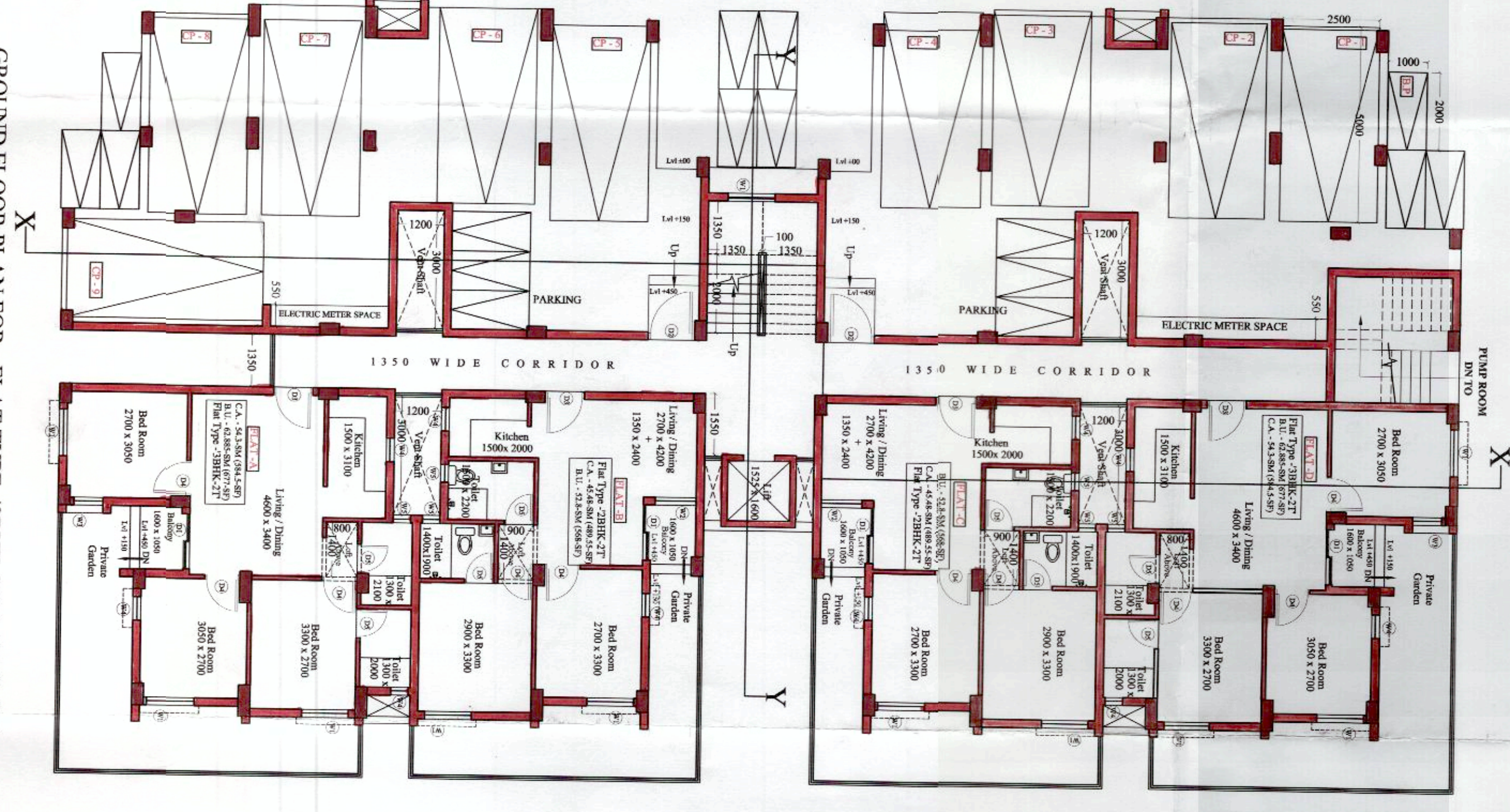
FRONT ELEVATION - 3BHK 2 TOI AND 2BHK 2 TOI BLOCK



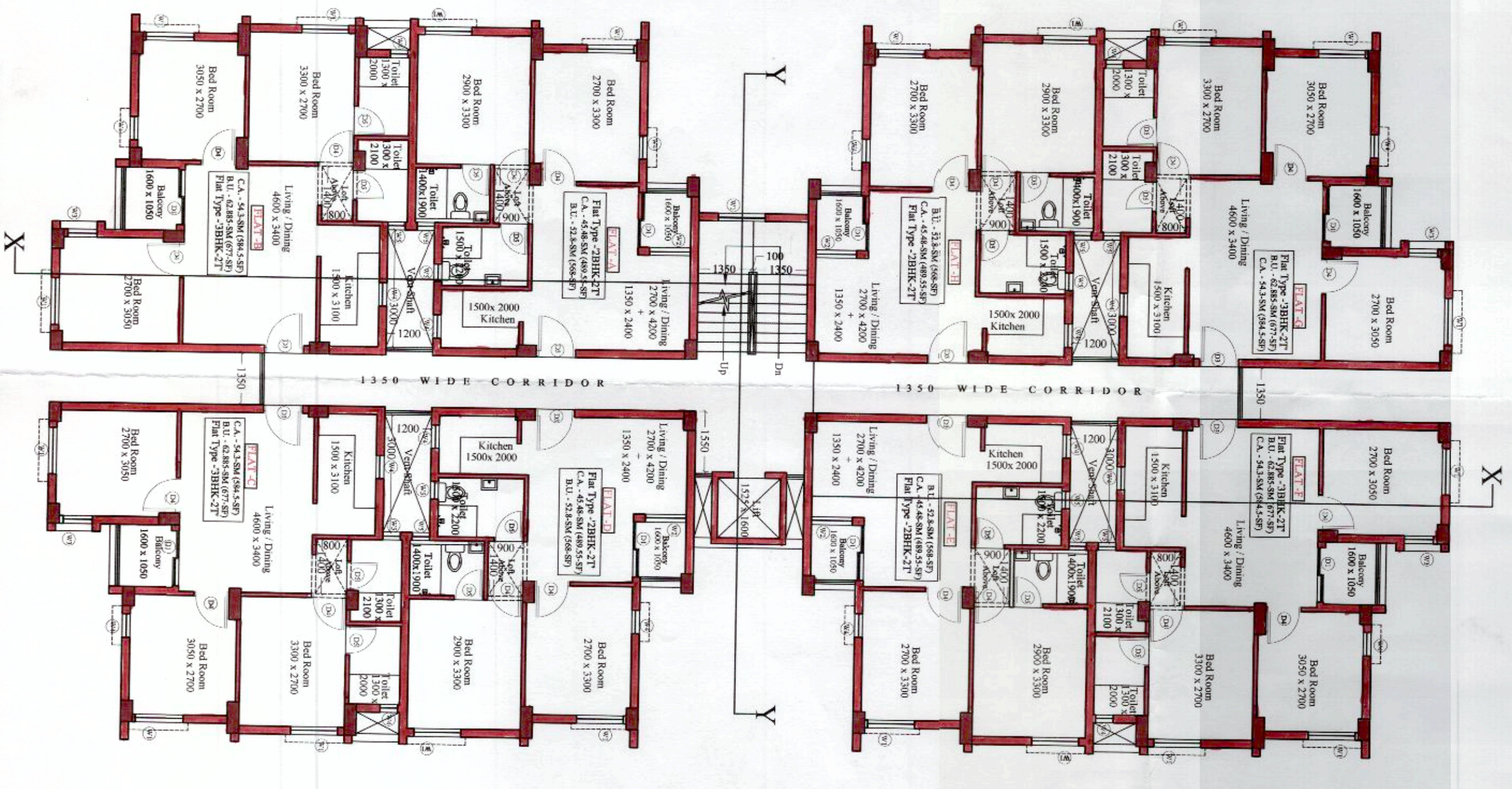

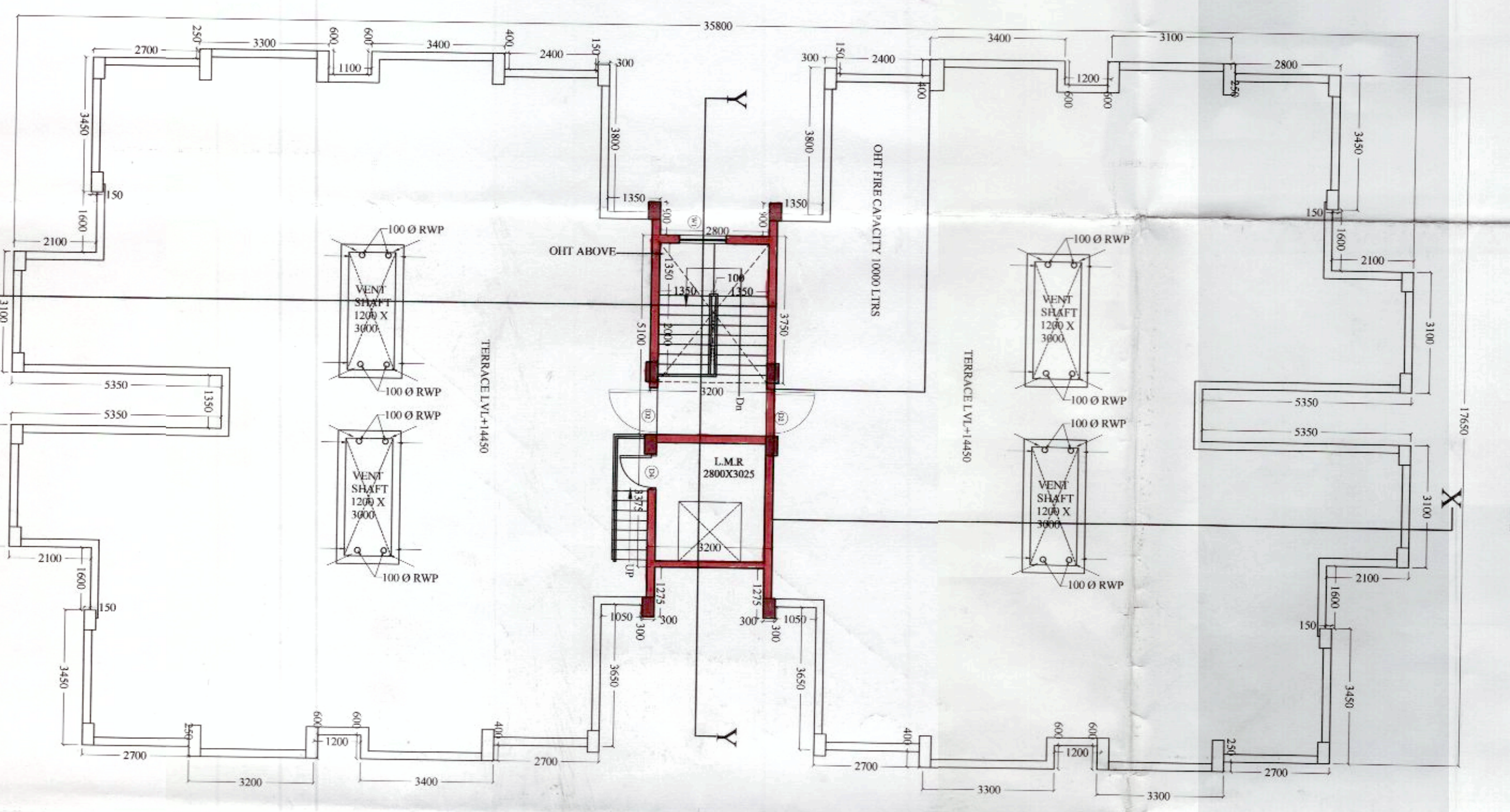

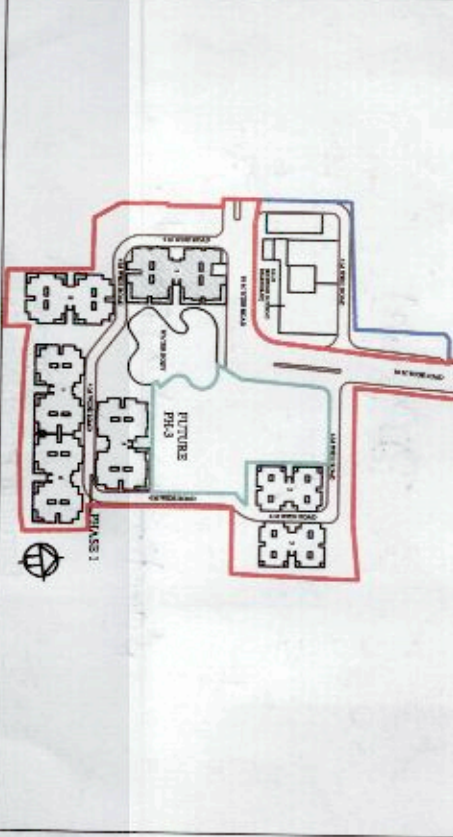
