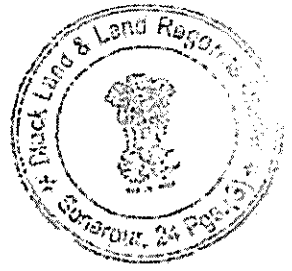

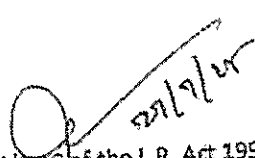

Schedule -II

(Terms and condition for Conversion)

- A. This permission for conversion is without prejudice to any of the provision of chapter -11 B of the W.B.L.R. Act, 1955.
- B. This permission for conversion is also without prejudice to any of the provision of Urban land (Ceiling & Regulation Act, 1979) applicable to the land involved.
- C. The permission for conversion will stand revoked if there is any violation of any of the provision of prevailing laws enforcing prevention of environmental prevention effecting public health in general of the locality at any point of time.
- D. This permission for conversion will also stand revoked if the land is used other then the purpose for which permission is given.
- E. This permission for conversion is also without prejudice to any of the provision of East Kolkata Wetlands (Conservation and Management Act, 2006, West Bengal Act VII of 2006)
- F. This permission for conversion is without prejudice to any of the provision to any of the provision of sub section (3) of section 6 of the West Bengal Estates Acquisition Act, 1953 (West Bengal Act, I of 1954)
- G. This permission for conversion is subject to approval or Licence form an appropriate authority where it is necessary to use the land for the purpose for which the conversion of land sought for.
- H. The land revenue shall be determined as per provision of section 23 of the W.B.L.R. Act, Section of Kolkata Land Revenue Act, 2003 as amended up to date.
- I. This permission for conversion is without prejudice to any of the provision of L.A. Act. 1948
- J. This permission is without prejudice to any of the provisions made under the existing Act, restricting felling of the terms.
- K. This permission is subject to permission from appropriate authority for construction Culvert / approach road form a Highway (Where it is necessary).
