That my eldest daughter Sumita and youngest daughter Sudipa are always looking after me physically, financially and in all respect.

That the husband of my second daughter Sucheta died in the year 1994 and I have given her my all bank balance and ornaments for the Welfare of her family, her heir only daughter Bidisha Sircar is married and settled in her

respective matrimonial home and almost enjoying liability free life; inspite of that Sucheta my second daughter is not looking after me and as such, I am not making any Provisions for her in this Will of my properties both movable and immovable.

I appoint Sri Anish Basu my eldest son-in-law to be the sole Executor of this Will. He will take Probate of this Will on behalf of the beneficiary.

I give devise and bequeath the entire 1st floor and roof alongwith all spaces in front and back portion of the ground floor of my house building being No. 162/D/570/1, Lake Gardens, to my eldest daughter Smt. Sumita Basu. She

will use and possess the front open space and car parking in ground floor and back portion of the ground floor, absolutely and forever only on pump room and water reservoir and staircase will be common with other owners and occupiers.

That my said daughter Sumita will be solely entitled to construct further floor or floors in the roof as per sanctioned plan by Calcutta Municipal Corporation for her own benefit or may sale the same if she require as and when and there will be no objection of the other beneficiary will be granted for that.

All movable properties, Cash, Fixed Deposits, Cash in Bank Accounts, Ornaments, after my death my eldest daughter

Sumita Basu shall inherit. No objection of the other beneficiary will be granted for that.

After making provision for my eldest daughter I give devise and bequeath the Ground Floor to my youngest daughter Sudipa Nayar and accordingly Sudipa will enjoy the absolute ownership of the Ground Floor excluding front and back space after my death absolutely and forever.

In case of construction in the present roof there will be equal right in the new roof between my daughters Sudipa and Sumita only.
