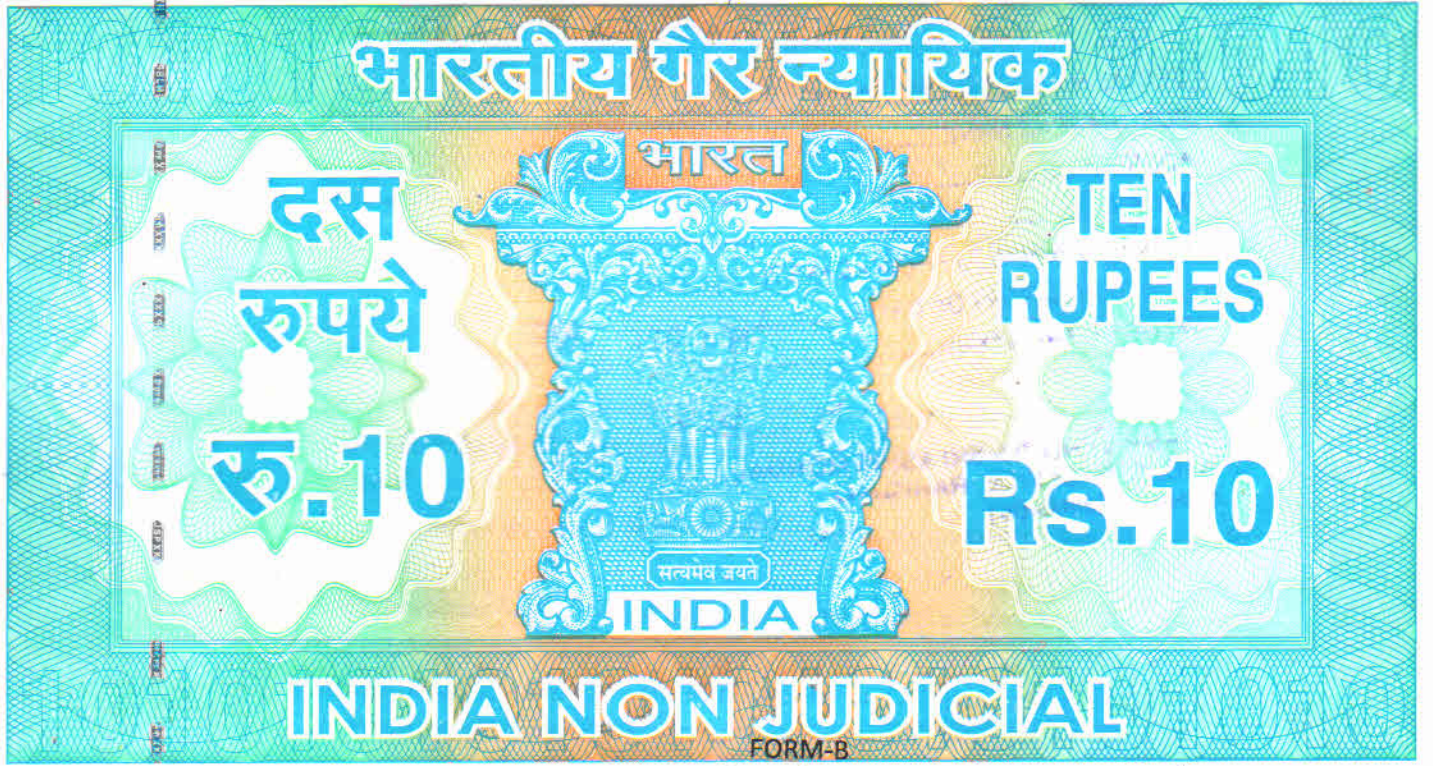

7. 9. That promoter has furnished such other documents as have been specified by the rules and regulations made under the Act.
