Dum Dum, District North 24 Parganas, S.P. No. 151, C.S. & R.S. Plot/Dag No. 1055 (P), under South Dum Dum Municipality in favour of Sri Sudhir Ranjan Rudra.
- (c) And, said Sri Sudhir Ranjan Rudra mutated his name in the records of South Dum Dum Municipality being Holding No. 151/ 1, Bandhab Nagar, Kolkata - 700028, and Ward No. 9.
- (d) And, said Sudhir Ranjan Rudra while seized and possessed of the said land died intestate on 11/07 /2022 leaving behind him his wife Smt. Smriti Kana Rudra & two daughters Smt. Suchismita Rudra Majumdar & Sudipta Rudra to inherit the property left by him.




