- (e) Vendors herein agree to sale the undivided 3 (Three) Decimals of land out of 23 (Twenty Three) Decimals of "Land" in R.S and L.R Dag No. 647, Khatian No. 190, L.R. Khatian No. 83, comprised in Mouza Manikpur, J.L. No. 77, Re. Su. No. 226, Touzi No. 412, Police Station Sonarpur, District 24 Parganas South, herein after referred to as the "Said Property" more fully and particularly described in the Schedule herein after written for the consideration of Rs. 5,44,500/- (Rupees Five Lacs Forty Four Thousand and Five Hundred) only.


