- That such information will be intimated to the competent authority and requisite permission or approval will be taken from the competent authority, if any, as mandated by law.
- 7. That the matter of Approval of WBFIRE clearance at the time of obtaining Final Completion Certificate will be intimated to the Allottees.
- 8. That the Rights and Interests of the Allottees will not be affected in any way with regards to the obtaining of WBFIRE Clearance at the time of final Completion Certificate.
