That Bengal Shriram Hi tech City Private Limited ('Owner/Promoter') have legal title to the land measuring about 1.69 Acres comprised in LR Dag No. 4474(P) in Mouza Konnagar under L.R. Khatian no. 11976, Police Station - Uttarpara, District - Hooghly, PIN-712246 within the ambit of the Kanaipur Gram Panchayat ('said Land') on which the development of the proposed project is to be carried out.

A legally valid authentication of title of such land is enclosed herewith.

- 1. That the said land is free from all encumbrances.

That Promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
