(b) In Page No. 5 in the 22th line the words "177 & 1118....." be substituted and read as ".117 & 118....." & now P.S. Panchasayar and in 24th line the word "Kolkata-700 075" be substituted and read as "Kolkata-700 099".

(c) In Page No. 19 in the 17 & 18th line the words "177 & 1118....." be substituted and read as "117 & 118....." & now P.S. Panchasayar and in 20th line the word "Kolkata-700 075" be substituted and read as "Kolkata-700 099"...

(d) In Page No. 20 in the 7th line the words "north-east....." be substituted and read as "south.....".

That as rectified and corrected as aforesaid the Principal Deed of Conveyance dated 8th day of June, 2022 shall remain in full force and effect in all other respect.
