

  - (c) In Page No. 19 in the 17 & 18th line the words "177 & 1118....." be substituted and read as "117 & 118......" & now P.S. Panchasayar and in 20th line the word "Kolkata-700 075" be substituted and read as "Kolkata-700 099"...
  - (d) In Page No. 20 in the 7th line the words "north-east....." be substituted and read as "south.......".


