4] DATE OF COMMENCEMENT :

The Partnership shall be deemed to have been commenced on and from the 18th day of September, 2020 and shall continue to be carried on until and otherwise determined by the partners mutually.

5] CAPITAL :

That the initial capital of the said Partnership Firm shall be the sum of Rs. 4,50,000.00 (Rupees Four Lakhs Fifty Thousand) only which will be contributed all the partners in the following manner :-

That if any further capital which may be required for effeciently carrying on the business hereafter, shall be contributed by all the partners from time to time.

6] SALARY :

The each of the parties shall be designated as partners and all the partners shall be entitled to get remuneration for serving the said firm as working partner.

The said remuneration payable to the working partners shall be as under :-

Partners are entitled to increase the salary in future by mutual consent in addition to bonous and dividend etc. And that the accounts of the business will be settled at the close of every financial year i.e. from the 1st day of April to the 31st day of March each year and attested by each of the aforesaid partners.

7] INTEREST OF CAPITAL :

That the interest at the rate of 18% per annum or as prescribed under Section 40(b) (iv) of the Indian Income Tax Act, 1961 or any other applicable provisions as may be enforced in the assessment for the partnership firm for relevant period shall be payable to the partners on the credit balance of each partners, such interest shall be calculated at the clossse of the accounting year. However in case of loss or lower income, rate of interest can be nil or lower than 18% as may be agreed to from time to time.

8] ACCOUNTING PROCEDURE :

That all expenses relating to the said business of the partnership firm including the remuneration to the said working partners and interest on capital contribution of all the partners shall be treated as expenses for the purpose of deriving profits of the firm and shall be divided and distributed amongst the partners before closing of the accounting period. 9] DRAWINGS :

That the Partners shall be entitled to withdraw any amount for their personal expenses from the funds of the partnership business against the amount standing to the credit of the Capital and/or current or loan account of the respective partners or their respective shares of profit for the relevant accounting year in such manner as may be decided by all the partners.

10] BANK OPERATION :

The Banker of the said partnership firm shall be such bank or banks as the Partners may think fit and the said bank account shall be operated jointly any two partners in the firm's name.

11] RATIO OF PROFIT & LOSS :

The net profit and Loss sharing ratio of the business determined as hereinafter stated shall belong to the said working partners in the following share and they shall also be liable for the losses in the same shares :

17] RESIDUARY CLAUSES :

None of the partners shall during the continuation the partnership without the consent of the other partner :

- a) Borrow except in the ordinary course of business any money from any person except from a partner for the purpose of the firm's business.

- e) Sell or mortgage or charge or otherwise dispose of his/her share in the assets or profits of the business.
- f) Draw, accept or endorse except of exchange or promissory note or hundi on account of business.

18] USUAL DRAWINGS :

Each of the partners shall be entitled to draw in each year in monthly instalment or otherwise such sum as may be mutually agreed upon on account of his/her personal expenses, payment of personal taxes and insurances premium.

19] REFUND OF DRAWINGS :

All such drawings shall be debited to the capital account of the partner's drawing the same. If on the taking of general account hereinafter mentioned it is found that a partner has drawn in excess of his/her share in the profit in that year, the excess drawings shall forthwith be refunded by the partner to the firm.

Be it further clearly understood by and between all the parties hereto that the aforesaid payment of salary, remuneration, bonus, Commission and interest on capital and loan etc. shall always be subjected to the unanimous decision of the partners and subjected to the conditions and restrictions which have been stipulated and enacted in by the I.T. Act & Rules framed there under and directions given by the C.B.D. from time to time as agreed upon by the Partners.

20] ACCOUNTING YEAR :

Accounting year of the firm will be 1st April to 31st March every year. As soon as possible at end of 31st March in each year during the continuation of the said partnership a General Account shall be taken upto the said date of the stock - in- trade, credits, properties and effects debts and liabilities of the said partnership and all transactions, matters and things usually by comprehended in a General account of the like nature. such account shall be duly audited if the partners think fit and proper and shall be balanced to agree to and sign by all the partners and when so signed shall be binding on them, except that, if any error be found therein by any of them and by signifying to the other within three months from the date of taking such account the same shall be corrected.

21] DEATH :

In the event of death of any of the partners, the partnership business shall not be dissolved but shall be continued by the surviving partner along with the nominee and heirs of the deceased partner to whose share the later may succeed.

22] RETIREMENT :
