

This is the last Will and Testament of one Nawab Sir Syed Shamsul Huda .

1. I bequeath one third of all my moveable and immoveable properties to Razia Khatun minor daughter of my younger brother S. M. Maseh Esquire Bar-at-Law whom I have brought up since her infancy as my own child .

2. I appoint my wife Hossaini Begum executrix of my Will . The said Hossaini Begum will be the guardian of the person and property of the said minor Razia Khatun until the said minor attains the age of majority. The said Hossaini Begum will cease to be the guardian of the person or property of the said minor if she does any act whereby under the Mohamedan Law she would be entitled to the custody of the said minor in case the said minor were/^{our}own child . On her ceasing to be the guardian of the said minor she will also cease to be executrix of my Estate. On Hossaini Begum's death or in the event of her being disqualified under the preceeding clause my brothers S. M. Maseh and S. M. Masih jointly or the survivor of them will be the executors or executor of this my Will .

3. I declare that premises No. 43 Collin Street and several other properties in the District of Faridpur and the house "Kunj-i-afeat" in Madhupur though purchased acquired or built at my cost stand in the name of my wife and were purchased acquired or built for her benefits . For further confirmation of title in her I have this day made a Hebabilewaz of all those properties to her for a consideration of Rs. 5/- which I had received from her and have put her in@nclusive possession of those properties . I have nothing to do with those properties .

4. I am indebted to my wife for her dower of fifteen thousand rupees as to which I executed a Kabin-namah in her favor on the sixteenty of December one thousand nine hundred and twelve . I have not thought it necessary to make any deduction out of the amount of the said dower for any gifts made to her up to this date .
