2. Nature of Document: Deed of Sale

Parties: Collectively the following which will include their respective successors-in-interest:

- 3.1 Vendor: DTC Projects Private Limited, a company duly incorporated under the Companies Act, 1956, having its registered office at Premises No. 1, Netaji Subhash Road, Kolkata 700 001, naving its PAN AALCSH016K, represented by its director Sri Ayush Jalan, son of Sri Dinesh Jalan, residing at 34. Ballygunge Circular Road, under P.S. Ballygunge, Kolkata-700 019, of the One Part AND
- 3.2 Purchaser: Amazing Residency Private Limited, a company duly incorporated under the Companies Act, 1956, having its registered office at Diamond Harbour Road, Kolkata-700 104, P.S. Bishnupur, having its PAN AAI CA1423D, represented by its authorised signatory Sri Subhash Tulsyan, son of Sri Ram Niranjan Tutsyan, residing at 138, G.T. Road, (South), Howrain 711102 of the Other Part.
- Subject Matter of Sate: Undivided 12.29 Decimals of 'Sali' Land comprised in various Dags situated in Mouza Daulatpur, P.S. Bishnupur, District South 24-Parganas morefully described in Schedule-C hereto (the "Said Property").

Background:

- 5.1 The Vendor is the sole and absolute owner of the Said Property. The devolution of title of the Vendor to the Said Property is mentioned in Schedule-A hereto.
- 5.2 The Vendor has represented to the Purchaser that the Vendor is the sole and absolute owner of the entirety of the Said Property free from all encombrances of any and every nature whatsoever including, but not limited to acquisition, requisition, lis pendens, attachments, liens, charges, mortgages, trusts, debutters, leases, tenancies, thika tenancies, reversionary rights, residuary rights, claims or stantfory probabilions.
- 5.3 In pursuance of the Agreement for Sale dated 21st January, 2013, as entered noto between the Vendor and the Purchaser, this Congeyance is now being expected to give effect to the transfer of the Said Property by the Vendor to the Purchaser.

6. Now this deed witnesses:

- 6.1 Sale: At and for the consideration mentioned in Cause 6.2, the Vendor doth hereby self and convey to the Purchaser the Property, absolutely and free from all encumbrances, which the Purchaser shall Have And Hold forever bereafter. It is a sale within the meaning of Section 54 of the Transfer of Property Act, 1882.
- 6.2 Consideration: This sale of the Said Property is being made by the Vendor at and for the total Consideration of Rs.6.14.500% (Rupeas six lab fourteen thousand and five hundred)

only, the entirety of which has been paid and/or to be paid by the Purchaser to the Vendor in the manner as follows:

- 6.2.1 Rs.80.000— (Rupees eighty thousand)only at or before execution hereof, the receipt whereof the Vendor hereby and by the Memo of Consideration below admits and acknowledges and releases the Purchaser and the Property of and from the same.
- 6.2.2 The balance of Rs.5.34.500 (Rupees tive lac thirty-four thousand and five numered only on completion of boundary wall of the said land or within 15 months of the said leed whichever is earlier.
- 6.3 Possession: Vacant, peaceful and khas possession of the Said Property has been handed over by the Vendor to the Purchaser, which the Purchaser doth hereby admit and acknowledge.
- 6.4 Covenant of the Vendor: The Vendor in future shall, at the request and cost of the Purchaser, do all acts and execute all deeds and/or documents that may be required for perfecting or henering the title of the Purchaser to the Said Property or more effectively transferring the Said Property to the Purchaser.
- 6.5 Indemnity: The Vendor hereby indemnifies and agrees to keep the Purchasor saved, harmless and indemnified against all actions, proceedings, claims, demnits, costs or expenses that the Purchaser may suffer or incur hereafter by virtue of any claim of any nature whatsoever in respect of any liabilities arising in connection with the Said Property or any part thereof, statutory or contractual, and the Vendor hereby further undertakes and covenants to forthwith pay, reimburse and/or make good such losses, expenses or costs incurred by the Purchaser, if any.

Schedule-Å [Devolution of Title]

- A. One Universal Electric Limited was the absolute owner of all that piece and parcel of land oneasuring an area of 2970 Decimals, more or less, in Mouza Daulatpur and Hanspukuria in the District of 24-Parganas (the "Total Land") acquired by it by thirty several Indontures of Conveyances on various dates herween 26th December 4961 and 23th lane. 1967
- By an order dated 9th January, 1986 passed by the Hon'ble High Court at Calcutta in Company Petition No. 428 of 1984 connected with Company Application No. 132 of 1984 the scheme of amalgamation made between the said Universal Electrics Limited and Shree Digitiaya Wooden Mills Limited was sanctioned and it was declared that the same would be effective from 12 July.

1983 and it was inter-aria ordered that all the properties, lights and interest and all liabilities and onnes of the said Universal Electrics, indued by transferred to and vested in the said Shree Digvijaya Woolen Mills Limited and accordingly the same stood, pursuant to the Section 394(2) of the Companies Act. 1956 transferred to and vested in the said Shree Digvijaya Woolen Mills Limited.

- By another Order dated 27th January, 1986 passed by the Hon'ble High Court of Guiana at Abmedatoat in Company Petition No. 409 of 1984 connected with Company Application No. 136 of 1984, the aforesaid scheme of amalgamation made between the said Universal electrics Limited and Shree Digwijaya Woolen Mills I mitted was also sanctioned by the said Hon'ble Court.
- D. The name of the said Shree Digvijaya Woolen Mills I imited was changed to VXI. India Limited and a fresh certificate of incorporation consequent on such change was issued by the Registrar of Companies, Gujarat on 13th June, 1986.
- The name of the said VXI, India Limited was further changed to Birla VXI.1 inited and a tress certificate of incorporation consequent on such change was issued by the Registrar of Companies, on 5th April, 1995.
- E. By an Indenture of Conveyance dated 23rd day of September, 1998 made between Birla VNI Limited therein referred to as the Vendor of the one part and VXL Landis & Gyr Limited therein referred to as the Purchaser of the other part and registered with the Registrar of Assurances, Calcutta in Book No. I. Volume No.110, Pages 346 to 407, Being No.5943 for the year 2001, the said Vendor therein granted, transferred, conveyed, assigned and assured unto and in favour of the Purchaser therein for the consideration therein mentioned all that the piece and parcel of freehold land having an area of fand measuring 1980 Decimals, be the same a little more or less, in Mouzas Daulatpur and Hanspukucia in the District of South 21-Porganas, out of the Total Lend, as described in the Second Schedule there made, written (the Said Land).
- G. The name of the said VXI. Landis & Gyr Limited was further changed to stemens Metering Limited and a fresh certificate of incorporation consequent on such change was issued by the Registrar of Companies. West Bengal, on 26th May, 2003.
- H. The name of the said Siemens Metering Limited was further changed to Landis + Gyr Limited and a fresh pertificate of incorporation consequent on such change was issued by the Registral of Companies, West Bengal, on 37th May, 2003.

- By an Indenture of Conveyance dated 8th day of September, 2005 made between Landis it Gyr Limited therein referred to as the Vendor of the one part and DTC Projects Private I mitted therein referred to as the Purchaser of the other part and registered with the Registrar of Assurances, Calcutta in Book No. I. Volume No. 1. Pages 1 to 23, Being No. 8455 for the year 2005, the said Vendor therein granted, transferred, conveyed, assigned and assured unto and in favour of the said DTC Protects Private Limited for the consideration therein mentioned all that the piece and parcer of freehold land having an area of land measuring 952 Decimals, be the same a little more or less, in Monzas Dauiatpur and Hanspukuria in the District of South 24-Parganas, out of the Said Land, as described in the Selfednie there under written.
- 3 After the execution and registration of the above said Conveyance it was found that there were various typographical and other mistakes in the Schedule to the said Indenture of Conveyance.
- K By a Deed of Rectification dated the 27th day of October, 2007 made between Landis Gyr Limited and the said DTC Projects Private Limited and registered with the Registrar of Assurances, Calcutta in Book No. 1, Volume No. 1, Pages 1 to 8, Being No. 06079 for the year 2008 the said mistakes in the Schedule were replaced and the Indenture of Conveyance dated the 8th day of September, 2005 was rectified.
- 1. Thus, the said DTC Projects Private Limited became absolutely seized and possessed of and/or otherwise well and sufficiently entitled to All That the said land measuring 952 decimal more or less in Mouzas Daulatpur and Hanspokuria in the District of South 24-Parganas more fully described in Schedule-B hereunder written (the "Larger Plot") free from all encumbrances, charges, liens, lispendens, attachments, acquisitions, requisitions, trusts of whatsoever nature.
- M. Upon being approached by the Purchaser, DTC Projects Private Limited, being the Vendor herein has agreed to self 12.29 Decimals of "Sali" land as comprised in various Dags in Monza Daulatpur morefully described in Schedule-C hereto out of the Larger Plot.




