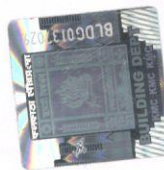

6. # The Building work for which this Building Permit is issued shall be completed within 22-DEC-28


Commencement of Erection/Re-Erection Not within two years will require fresh application for sanction
