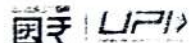

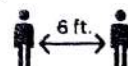

WHEREAS both the Partners have gathered experience in the profession of construction, development & other related ancillary works and the said related persons have now intended to start for a business of construction, development & other related ancillary works after investing initially Rs.2,00,000/- (Rupees Two Lakhs) only each for the said business.

AND WHEREAS the parties herein have also decided to work jointly as Partners and to that intent the Partnership herein contemplated is being started on the guideline principles terms and conditions hereinafter appearing.

THIS DEED OF PARTNERSHIP WITNESSETH as follows :-

1. **THAT** the name of the Partnership will be " **S.T.R.S. ENTERPRISE**" and the principal business is at Ranabhutia, Post Office : Panchpota, Police Station : Sonarpur, Kolkata : 700152, District : 24-Parganas (South), The principal place may be shifted to any new place in Kolkata as may be determined by the partners from time to time.
2. **THAT** the Partnership will be constituted the Partners named above. The Partners may if they so like registered their Partnership firm under the Partnership Act.
3. **THAT** the Partners will have right to take any other person mutually to join their firm as Partner/Partners. They will also have the right to change constitution of their firm and convert the same into a Private Limited or Limited Company under the Companies Act.
4. **THAT** the place of business of the Partnership will be for the present at Ranabhutia, Post Office : Panchpota, Police Station : Sonarpur, Kolkata : 700152, District : 24-Parganas (South), The Partners will have right to shift their said business to any other place and or open and operate further offices as branch offices of the said principal place of business.
5. **THAT** the object of the Partnership is to carry on a business of construction, development & other related ancillary works. The Partners will have the right to extend their business to any other or further time to times as they mutually decide.
6. **THAT** the activities of the Partnership shall continue so long as the Partners desire to continue.

7. THAT the capital of the Partnership for the time shall be the sum of Rs.8,00,000/- (Rupees Eight Lakhs) only on made up by all the Partners of Rs.2,00,000/- (Rupees Two Lakhs) only each. The said Partners will have the right to make further contribution and increase the Capital of the Partnership. The Partners jointly will have also the right to borrow moneys for and in the name of the Partnership if the Partners so desire for further development of their business from any financial institutions like Bank etc.

8. THE PARTNERS will be entitled to draw a sum of Rs.5,000/- (Rupees Five thousand) only each as their allowance from the Partnership business for the service rendered by them in the business of the Partnership. The said rate of allowance shall be renewed after one year and the new rate befitting the then status of the said business shall be fixed a fresh.

9. THE PARTNERS shall maintain proper account of the business transactions and keep, maintain the necessary books of account duly posted upto date. All such books of account and related papers, records and documents shall be at all times be kept at the place of business of Partnership. None of the Partner shall remove the same from the place of business nor take the same or any of them in his personal custody.

10. The accounting year of the Partnership shall always be the financial year that is from 1st day of April in a year ending on the last day of March in the year immediately following.

11. That during the continuance of the Partnership business accounts shall be taken on 31st March every year, of all the capital assets and

liabilities and of profit and loss of the Partnership business and the accounts of the business for the year ending 31st March as above shall be closed. The finally prepared Annual Accounts shall be signed by both the Partners and thereupon the so finalised account shall be binding upon the Partners.

12. It is agreed by both the Partners that the share of each partner will be equal as hereunder –

- a) Sri Subhas Das, Party of the First Part - 1/4 ✓
- b) Sri Tapan Panja, Party of the Second Part - 1/4 ✓
- c) Sri Ripan Haoladar, Party of the Third Part - 1/4 ✓
- d) Sri Shumangal Dhali, Party of the Third Part - 1/4 ✓

13. It is further agreed that the Parties hereto i.e. all the Partners of the said business shall gain and/or sustain Profit and Loss equally as per their shares in the business.

14. THAT the partners shall devote their whole time and attention for the benefit and development as also for smooth running of Partnership business.

15. THAT no partner shall singly borrow money in the name of the Partnership business without the knowledge and consent of the other Partner.

16. THAT both the Partner shall pay their separate debts and indemnify the other partner and the assets of the firm against the sum and all expenses therefor. The Partnership firm shall not stand as guarantor for any of the Partners for his/her personal debts and liabilities.

17. THAT the Partners shall have right to take inspection on examine the books of account of the Partnership on working days during office hours at the place of business without causing hindrance to the normal operation of the business. The Partners will also be entitled to take copies of at extracts from the books of account and other records related to the business of the Partnership.

18. THAT all the Partners shall inform the other properties of all letters, accounts, writings and other things which shall come to his/her hands of knowledge concerning the business of the Partnership.

19. THAT neither Partner shall without specific consent of the other partner do or cause to be done any of the following acts.

19.1 Neither directly nor indirectly engage or be concerned or interested in any business of like nature during the continuance of the present Partnership business.

19.2 Appoint any staff or menial workers and/or dismiss any agent or servant of the Partnership Firm.

19.3 Lend any moneys or deliver on credit any of the things/assets of the Partnership firm to any person or persons whom the other Partner has previously in writing forbidden to trust.

19.4 Except in ordinary course of business give any security or promise for payment of money on account of the Partnership.

19.5 Assign or charge his/her share in the assets or profits of the Partnership firm.

19.6 Draw and accept or endorse any promissory note on account of the firm.

19.7 Remit the whole or any part of any debt or sum due to the Partnership business.

19.8 Save and except in the ordinary course of trade dispose by pledge, sale or otherwise any part of the Partnership's profits.

20. THAT the Partnership will have at least one Banking account with any of the Banks at a Branch convenient for the Partners to transact business with such Banking Account shall be operated by both Partners jointly or severally. The Partners will have the right to open and operate more than one Banking Account.

21. THAT all moneys and instruments of money shall be deposited in the Banking Account or Accounts of the Partnership. The Partners will however have the right to keep such cash at the place of business of the Partnership as may be deemed necessary for meeting the day to day expenses.

22. THAT if any Partner desires to quit, retire from the Partnership he/she may do so by giving three months' notice in writing to the other Partner and on the expiry of the notice period the retiring Partner will be entitled to withdraw his/her contribution in the capital and other moneys as may at the relevant time and to the credit of the retiring Partner.

23. THAT if during the tenure of the Partnership Business any Partner dies, in that event his/her/their legal heirs may join in the Partnership business and step into the shoes of the deceased Partner.

24. THAT if for any other reason hurring the Partnership business any Partner becomes an insolvent and/or physically or mentally incapable of

looking after the Partnership business in that event the so affected Partner shall be dropped from the Partnership and/or in his place a fresh Partner may be taken or the business may be wholly taken up by the other Partner after making payment of capital or other moneys at may at the relevant time stand accrue to the credit of him/her.

25. THAT in the event of one of the partner withdrawing from the Partnership, the Other Partner may either continue the business in manner prescribed in the preceding clause no. 22 or may publish notice of dissolution of Partnership in the local official gazette and in local vernacular newspaper and also inform the Registrar of Firm in writing.

26. THAT if the instant Partnership shall be deemed to have started on and from the date of execution of these presents by the Partners.

27. THAT the Partners will have the right to make additions and alterations to and in the terms and conditions hereof whenever they may mutually decide in favour of making such addition and or alteration.

28. THAT any notice hereby required or authorised to be given by any of the Partner to the other, shall be sufficiently given by leaving the same addressed to him/her at the Principal place of business of the Partnership firm or by sending the same by prepaid registered post to his/her usual or last known address.

29. The local Court of local jurisdiction of Kolkata exclusively have the jurisdiction to entertain and try all disputes, proceedings or actions by any between the Parties hereto.







