Also the surviving Executor Prabir Kumar Biswas on 12th October 2018 has duly executed a Deed of Assent to the Beneficiaries in the Last Will and Testament being the Releasees herein which was duly registered in the office of the Additional Registrar of Assurances – IV, Kolkata in Book No. I, Volume No. 1904-2018, Page from 445640 to 445658, Being No. 190411357 for the year 2018.

AND WHEREAS Sailabala Biswas the Testatrix apart from bequeathing her property as stated hereinabove she created a life interest in favour of her daughter in law Jyotsna Biswas the Releasor herein.

AND WHEREAS as a consequence whereof Smt. Jyotsna Biswas widow of deceased Samir Kumar Biswas is seized and possessed of or otherwise well and sufficiently entitled to ALL THAT one room on the First floor of the said Two Storied Building measuring 120 Square feet, hereinafter referred to as the "said property" (morefully written in the Second Schedule herein).

The Releasor doth hereby and hereunder further agree, declare, confirm and acknowledge the good, right, full power and absolute authority and indefeasible title of the Releasee to grant, convey, sell and transfer the said property or otherwise to deal with the property or otherwise to deal with the corpus or income thereof in any manner and on any terms as the Releasee shall or may think fit and proper and even without the consent or concurrence of or any reference to the Releasor or her heirs, executors, administrators.

AND THIS INDENTURE FURTEHRMORE WITNESSETH that for the consideration hereinbefore stated the Releasor doth hereby and hereunder acquit, release, discharge, grant, convey, transfer and assure unto and to the use of the Releasees the said property and every part thereof together with all
