#### WHEREAS:

- At all material times Ajoy Kumar Das , son of Late Ashutosh Das of 19. S. N. Banerjee Road, Kolkata-700013 were in possession of several immoveable properties besides their Zamindari and land measuring 12 Cottahs 9 Chittaks 43 square feet land in premises No.-6K, Kedar Nath Das Lane including property mentioned schedule hereunder written .

## THE WEST BENGAL SOCIETIES REGISTRATION ACT, 1961. REGULATIONS OF ASSOCIATION

#### MEMBERSHIP:

#### 1 Admission:

The signature to the Memorandam of Association & the office bearers of the Governing. Body of the society shall be first members of the society. The Governing Body may admit to membership any person of any caste, creed or sex who has attained the age of 18 years and agreed in writing to be bound by the society and who in the opinion of the Governing Body will be interested in advancement of the society.

Be it noted here that the power to admit members is the sole and absolute power of the Governing body and the Governing Body may refuse to admit any person as a member without assigning any reason therefore.

#### 2 Types of Members :

- 1) Honorary Members: Any person, whose connection with the society is deemed to be useful may with the consent of such person be elected as honorary member of the society. Such members shall not, however, be eligible to be members of the Governing Body nor shall be entitled to vote in any meeting.
- 2) Ordinary Members: Any person, qualified to be a member and paying prescribed ordinary membership fee be admitted as ordinary of the society.
  - 3) Cessation of Membership: Any member shall cease to be a member

    (a) on the acceptance of his/her resignation from membership, (b) on his/her becoming insane or insolvent, c) on his/her conviction of any offence in connection with the formation promotion, management or conduct of affairs of society or a body corporate or of any offence involving moral turpitude.
- 4) Register of Members: The society shall maintain a register of members containing the names, address and their occupation, the date of admission and of cessation of membership.

  The Register will be kept open for inspection of the members of the society on requisition. All entires required to be made therein shall be entered within a period of 15 days.

- Any ordinary member of the society has the right (a) to elect and to be elected in nay election of the society. (b) to submit suggestion for discussion to the Governing Body and subcommittee on any matter relation to society on appointment with the Secretary c) to pay his/her subscription within the prescribed time. Defaulting members shall be allowed to take part or vote in a meeting. Members shall have one vote each.
- 6) Expulsion & Removal: Frequent actions of nay members, it found by the Governing Body determental to the interest and in volation of the regulations of the society, he/she may be after due enquiry, censured, suspended or expelled from the membership by the Governing Body.

In that case the Governing Body shall first serve the member concerned with a show cause showing therein the charges framed and ask his/her to submit his./ her statement of defence with a month. On receipt of the explantion the Governing Body shall have the power to take a suitable action against the received within a month, the Governing Body may take as exparte decision.

For any act of expulsion or terminted no such members shall be entitled to prefer any claim for compensation or damage even if proved on subsequent date that such act of expultion or termination was wrongful and / or unlawful.

#### GOVERNING BODY

1) Composition, election/apointment resignation/removal terms of office :

There shall be a Governing Body consisting of not less than 7 members. The office bearers of Governing Body shall comprise of President, Vice Presidents, Secretary, Asst. Secretary, Treasurer and other committee members.

The office bearers & other committee members shall be elected at the A.G.M.

The resignation and removal of the Governing Body members shall be dealt with as has been prescribted as in the case of other members noted herein before.

### TERMS OF ELECTION

The term of office of the Governing Body shall ordinarily be once in three year, unless it is dissolved /terminated early under unforeseen circumstances. After election, the old Governing body will continue to function till the new body takes over charge which shall under no circumstances be more than 30 days from the date of election.

- 2) Meeting: A meeting of Governing Body shall be held at least once in three months at such place, date and time, as the President of the Secretary may determine. Any six members of the Governing Body may requisition the president on the requisitions may do so provided no business other than specified in the notice shall be transacted at such meeting.
- 3) Notice and quorum. 7 days notice of the meeting specifying the place, time and the general nature or business to be transacted shall be every member of the Governing Body.

  Emergncy meeting may be called on 24 hours notice. 1/3rd members personally present shall constitute a quorum for the meeting and of a quorum is not present within 30 minutes of the time, members present shall adjourn the meeting.
- 4) Procedure of the meeting: The President or in his absence Vice presidents shall preside over all meeting of the Governing Body and in their absence members present shall elect a chaiman of the meeting. All questions before the meeting will be decided by a majority of votes, each member having one vote. The President shall have a second or casting vote in addition to his/her own vote in case of equality of votes.
- 5) Power and Dutes of the Governing Body: The Governing Body shall have general power of supervision and conduct over all the affairs of the society and in particulars shall discharge the following duties (1) appoint sub-committee with such power and duties as may be considered necessary or expedient.
- (ii) To accept donation, gift, subscription, movable or immovable property for the objects of the society. (iii) To sell lease, mortgage or otherwise dispose of and deal with all or any part of the properly of the society. (iv) To co-opt not more than two members to the Governing Body.

  vi) To appoint a person or persons on payment to assist the Secretary / Treasurer in the maintenance of account. Etc. (vii) To conduct any other business not specified herein for the attainment of the objects of the society provided such business is not repugnant to such object.

### SAFE CUSTODY OF PROPERTIES :

The Govening Body shall be responsible for the safe custody of the funds, properties and assets of the society.

The funds of the society shall be kept in bank/post office/mutual funds and be invested in any securies specified under sec 20 of the Indian Trust Act, 1882.

## BOOKS OF ACCOUNTS INSPECTION :

The books of account and other statutory books shall be kept at the registered office and shall be open to inspection of the members at such time and place as the Governing Body directs on within request made by any members.

#### ACCOUNTING YEAR :

The accounting year of the society shall be from 1st day of April of each year to 31st day of March of following year

#### BANK OPERATION :

The Barking accounts of the society shall be operated by the Secretary , President ,Treasurer or any two of them jointly.

#### GENERAL MEETING :

#### Annual General Meeting:

Notice: The Secretary shall annually call the Annual General meeting as per provisions of W.B.S.R. Act , 1961 giving at least 14 days's notice to all members. The notice shall contain the place date, day and time of the meeting.

Agenda: The business to be transacted at the A.G.M. shall be (a) to confirm the minutes of the last A.G.M. and of special general meeting if any, (b) to adopt with or without modification the report of the working of the previous year. C) to pass audited accounts of the society for the previous year ended, (d) to appoint qualified Auditor or Auditors (e) to transact such business as may be fixed by the governing body; (f) to transact such other business as may brought forwards by giving 14 days previous notice from any member, (g) to conduct general election.

Quorant of the meeting:

1/3rd members personally present at the commencement of the meeting shall constitute the quorum.

Contd P/5.

Manner and method of voting: The Chairman of the meeting shall decide the manner and method of voting at the outset of the meeting.

Special General Meeting: A special General Meeting may be convened by the governing body at any time in view of urgency of the matter. At least 7 days notice shall be given to every for special general meeting.

Members may request the Governing Body for special General Meeting by placing a requisition signed by 2/3rd of total members. In that case the Governing Body shall conveyance a speical general meeting with a month from the receipt of such notice. In default by the Governing Body, the requisition shall behold such meeeting provided no business other than those specified in the notice shall be transacted.

Extra-ordinary general meeting: The Governing Body may direct to conveyance an Extra-ordinary general meeting for consideration of addition, alteration of amendment of the memorandum / regulations of the society 7 days notice along with the proposed draft of charge shall be sent to members before the meeting. The regolution for change, amendment etc. of the Memorandum and Regulations be carried out it accepted by the three fourths of the members present at the meeting.

## DUTIES OF THE OFFICE BEARERS

President: He/She shall (a) preside over all all meeting of the society, (b) take all disciplinary actions such as removals, dismissal etc. in consultation with the Governing Body, c) advice the Secretary in any matter required urgent attention. (d) call emergency meeting.

Vice President: (a) He/She shall preside over the meeting in the absence of president, (b) Vice Presidents shall take charge of each programme of the society.

Secretary: He / She shall (a) convene all meeting of the society, (b) maintain minute books of all meetings, c) issue general circular and notice, (d) receive all applications for membership which shall be placed before the Governing Body, (e) sign on behalf of the society all receipts for all sums received as subscription etc. (f) sign and give pay order on all bills for payments, (g) get the accounts of the society audited by a Chartered Accountant; (h) ensure comphance with statory requirements, (i) tranact all other business subject to the direction of the Governing Body.

Asst. Secretary: (a) He/She shall help general secretary in performing his dutes, (b) in absence of general secretary they will perform the duties of general secretary.

Treasurer: He/she shall (a) collect and receive all sorts of subscription, donations and deposit of money and grant receipts thereof; (b) maintain and keep cash book and such other accounts as are necessary,c) prepare the budget in cirsulation with the Secretary for consideration of the Governing Body.

## MAINTENANCE AND AUDIT OF ACCOUNTS :

The society shall maintain books of accounts as required under Sec. 15(1), (a) (b) of the Act.

The accounts shall be audited by a duly qualified auditoras stated in Sec. 15(2) of the Act.

SUIT & LEGAL PROCEEDINGS:

All suits and legal proceedings by or against the society shall be in the name of the Secretary or such person as shall be appointed by the committee.

## ALTERATION OF THE MEMORANDUM & REGULATIONS :

The Memorandum and regulations may be altered, modified, rescinded or added to be special resolutions passed by the 3/4th members in a general meeting called for the purpose.

The governing Body shall have powers to make, alter modify or rescind such Regulations as may be considered necessary in the interest of smooth functioning of the society.

### DISSOLUTION OF SOCIETY :

Subject to the provisions of sections 24 & 27 of the West Bengal Societies Registration Act, 1961 or any statutorymodifications thereof, the society may be dissolved by a resolution to that effect passed by 3/4th members of the society at a general meeting. The said meeting shallalso decide the manner of disbursement of the funds and assets of the Association, if any after dissolution.
