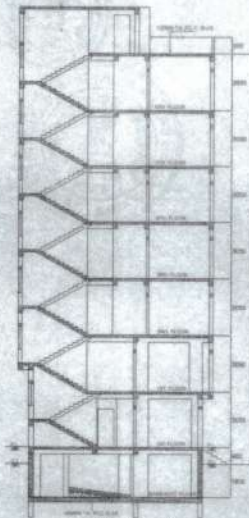
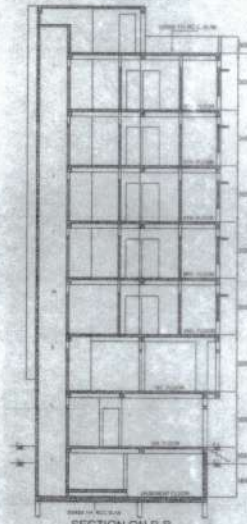


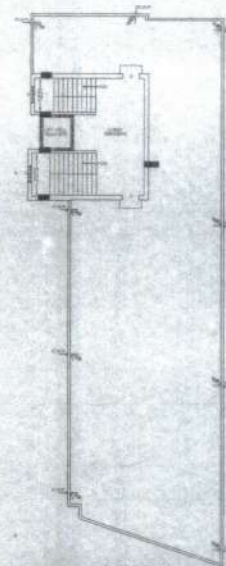
FRONT ELEVATION

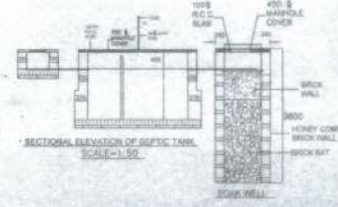
SECTION ON A-A

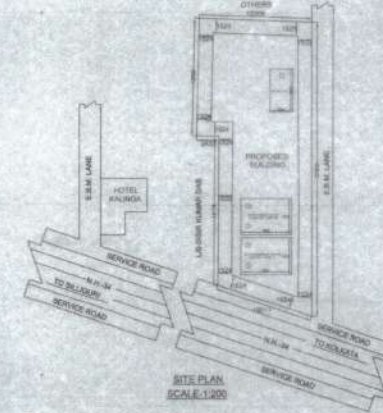
SECTIONAL ELEVATION OF SEPTIC TANK

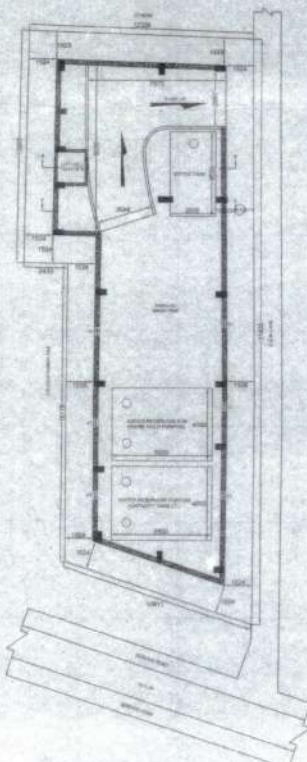

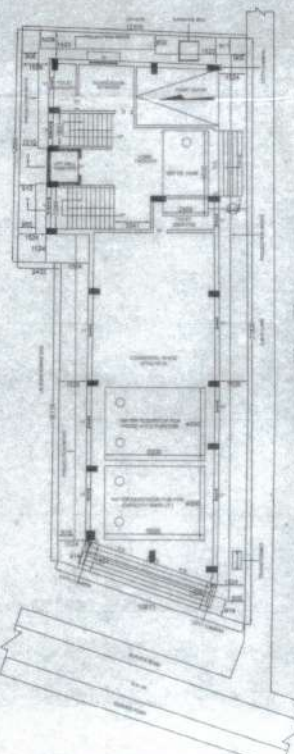

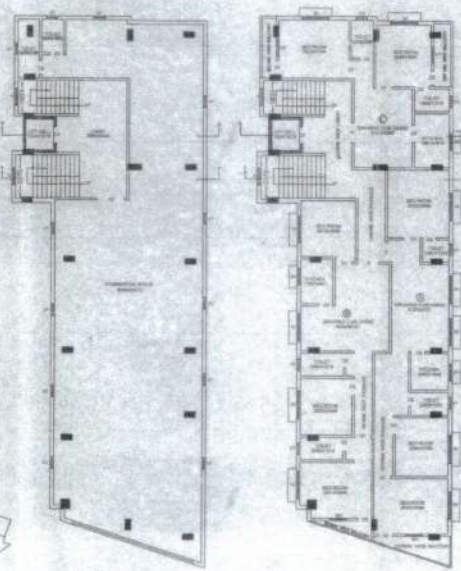

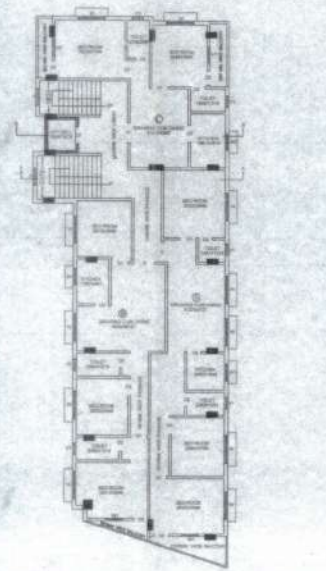
PROPOSED BASEMENT FLOOR PLAN

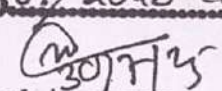
