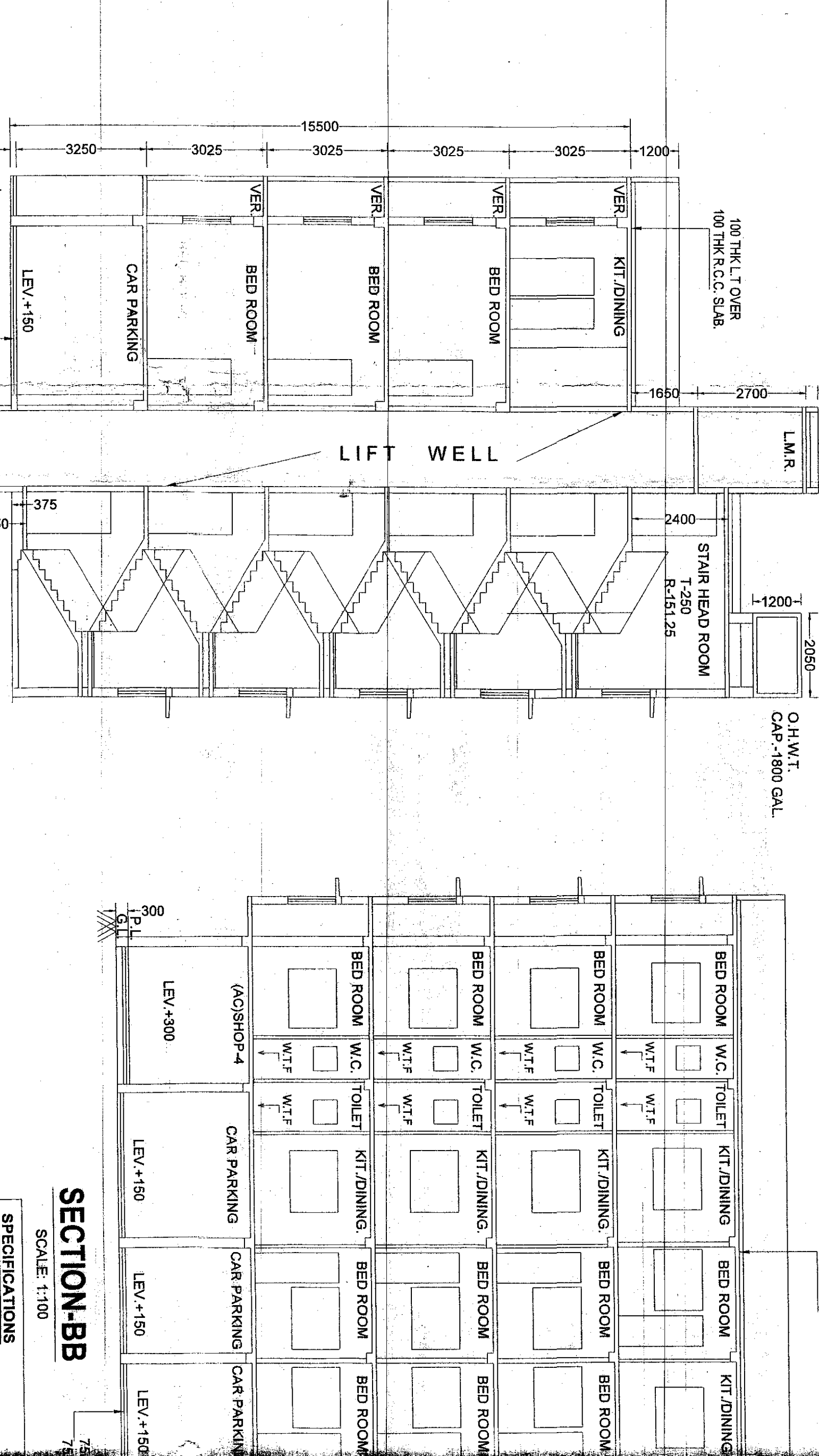
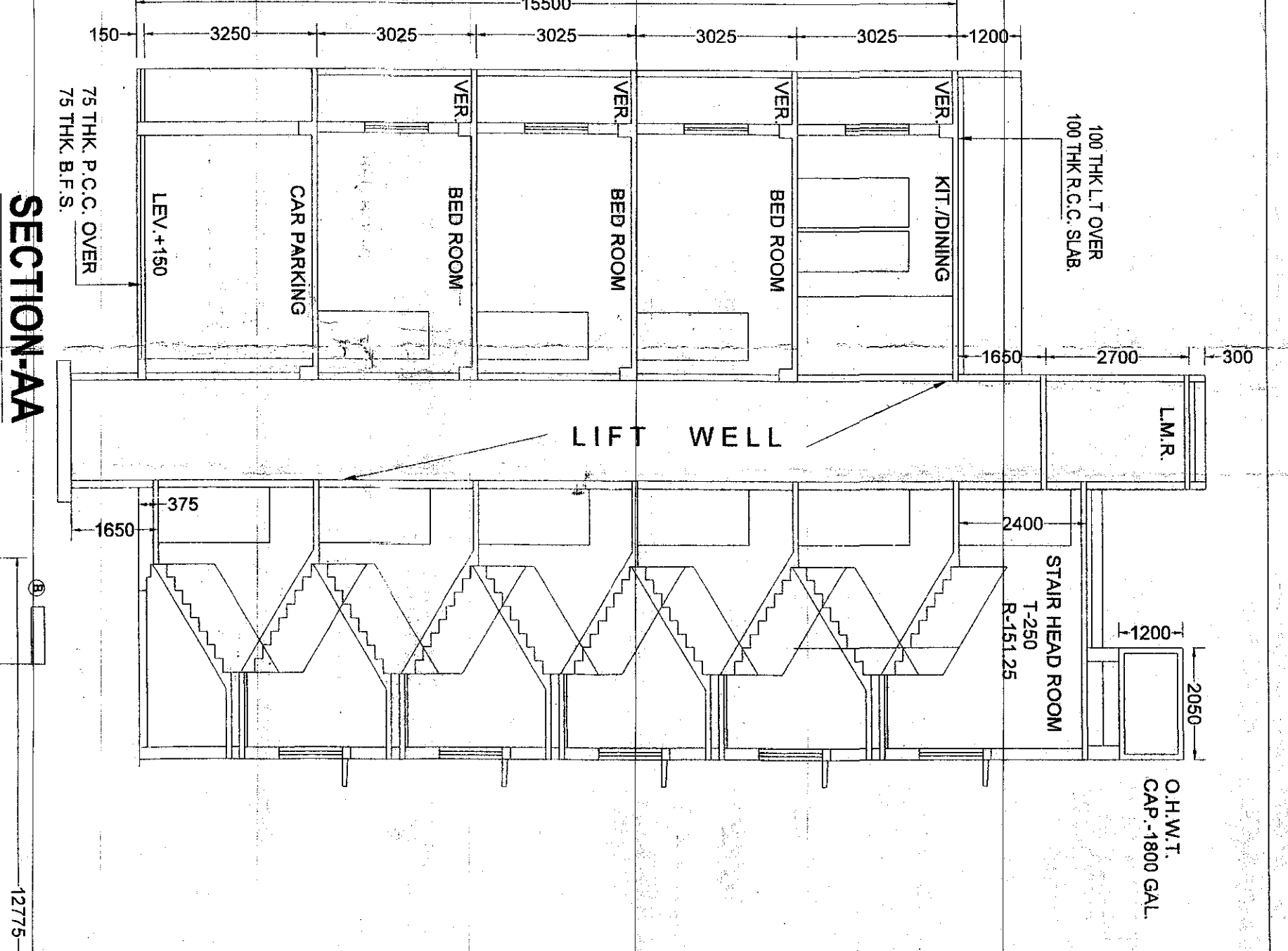


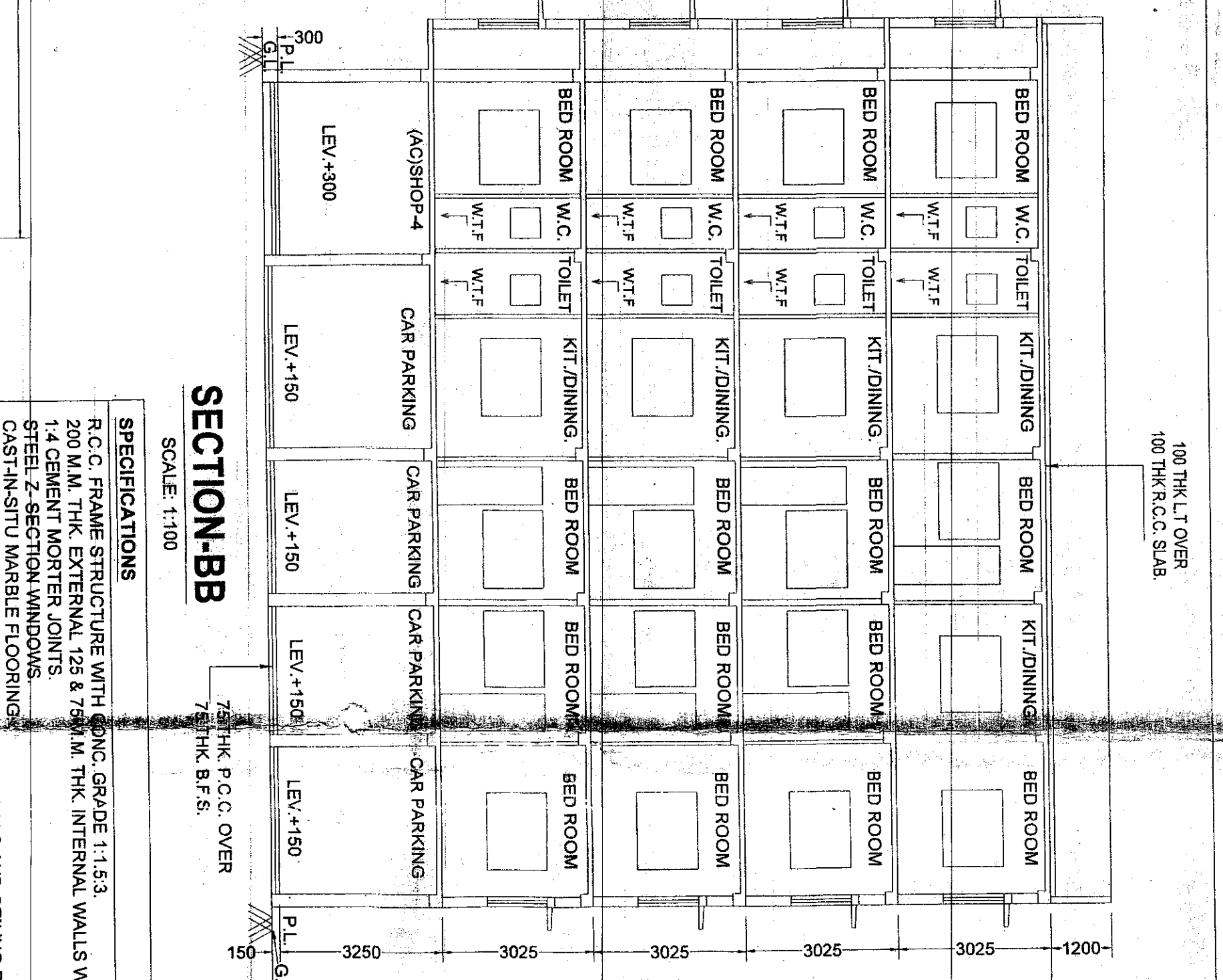
FRONT ELEVATION

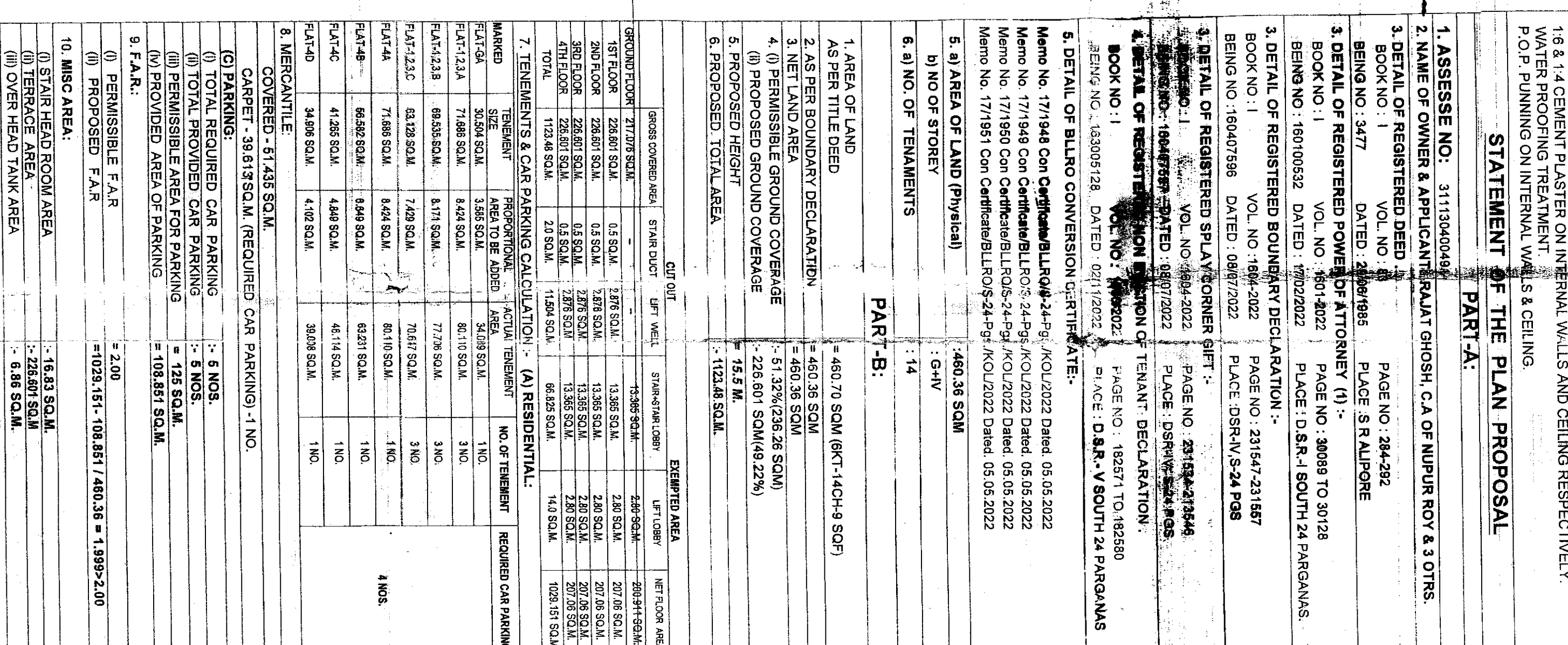
GROUND FLOOR PLAN
