- 2. PRINCIPAL PLACE OF BUSINESS: That the principal place of business shall be locked at JM-11/B, Aswininagar, Vidyasagar Pally, P.S. Baguiati, Kolkata 700159, Dist. North 24 Parganas, or it any other place or places as the partners may mutually determine from time to time.
- DURATION OF PARTNERSHIP: That the partnership is hereby constituted shall be deemed to have commenced on and from the date of execution of the Deed and the same shall be at a Partnership at WILL.

- 12. SHARE OF PROFIT AND LOSS: That the profit and loss of the firm shall be divided equally amongst the partners.
- 13. PROPERTY OF THE FIRM: That the property of the firm shall include all properties, rights, titles and interest in the properties of firm and the properties by virtue of agreement, purchase or otherwise acquired in course of firm's business.
