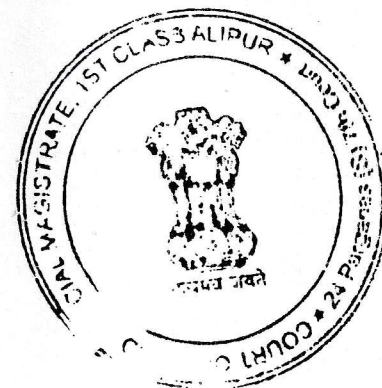

AFFIDAVIT

3. That my said elder brother namely Asim Kumar Ghose alias Ghosh since deceased, during his lifetime acquired and possessed and /or was the sole and absolute owner of Premises No. 130, Purba Diganta ,
(Santoshpur), Police Station – Survey Park, Kolkata- 700075, under Word No. 109, Borough No. XII of the Kolkata Municipal Corporation. The said property was registered at the Office of the District Sub- Registrar, Alipore, South 24 Paraganas on 16.06.1980.

That my said elder brother namely Asim Kumar Ghose alias Ghosh since deceased also mutated his name before the Kolkata Municipal Corporation in respect of the said property and also possessed the same during his lifetime without any disturbances or hindrances from any corner of the world being the sole and absolute owner of the same.
