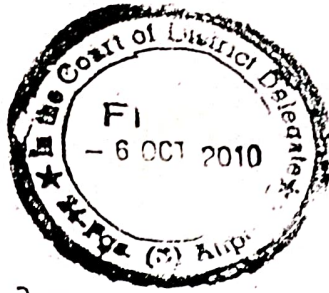
My wife SMT. KAMALA GUPTA is alive.

I do hereby give, devise and bequeath my aforesaid property as hereunder :-

KAMALA GUPTA will have life estate of my aforesaid property and she will have right to possess and occupy the aforesaid property and enjoy usufruct thereof till her death and thereafter my aforesaid retarded and/or deranged daughter KUMARI SHARBANI GUPTA will enjoy the same right with regard to my aforesaid property till her death. But none of them shall have right either to transfer the aforesaid property in anyway whatsoever or encumber the aforesaid property in anyway whatsoever.

(b) After the death of my wife and my said retarded daughter KUMARI SHARBANI GUPTA, i.e. after the death of both of them, my other two daughters viz. SMT. DEBJANI NEOGY, SMT. NANDINI DASGUPTA and my daughter-in-law SMT. SUMAYA GUPTA will have the aforesaid property in equal share and they will have unfettered right to deal with my aforesaid property, jointly in whatsoever manner as the absolute owners thereof.

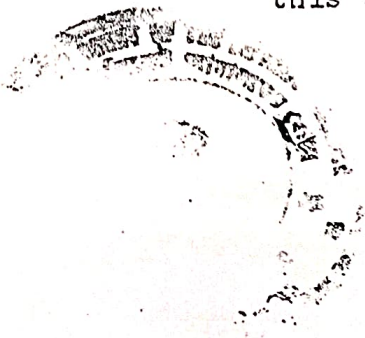

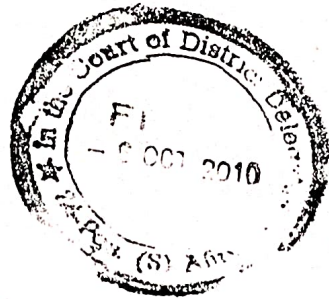
