Barrackpore, Dist. North 24 Parganas, Kolkata – 700120, one of the partners of TARA MAA ENTERPRISE, a partnership firm, having its registered office at 28/4/1, park Road, P.O. Talpukur, P.S. Titagrah, Dist. North 24 Parganas, Kolkata – 700123, promoter of the proposed project named "MAA JANKI BHAWAN-I", do hereby solemnly declare, undertake and state as under:

- I/Promoter have/ Owner, Smt. Rekha Rani Haldar has a legal title to the land on which the development of the proposed project is to be carried out AND
 - a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for the development of the real estate project is enclosed herewith.
- 2. That the said land is free from all legal encumbrances.

That the time period within which the project shall be completed by me/ promoter is 31st March, 2027.
