PLAN SHOWING THE LAND OF MOUZA GOPAL MATH J.L. NO. 54

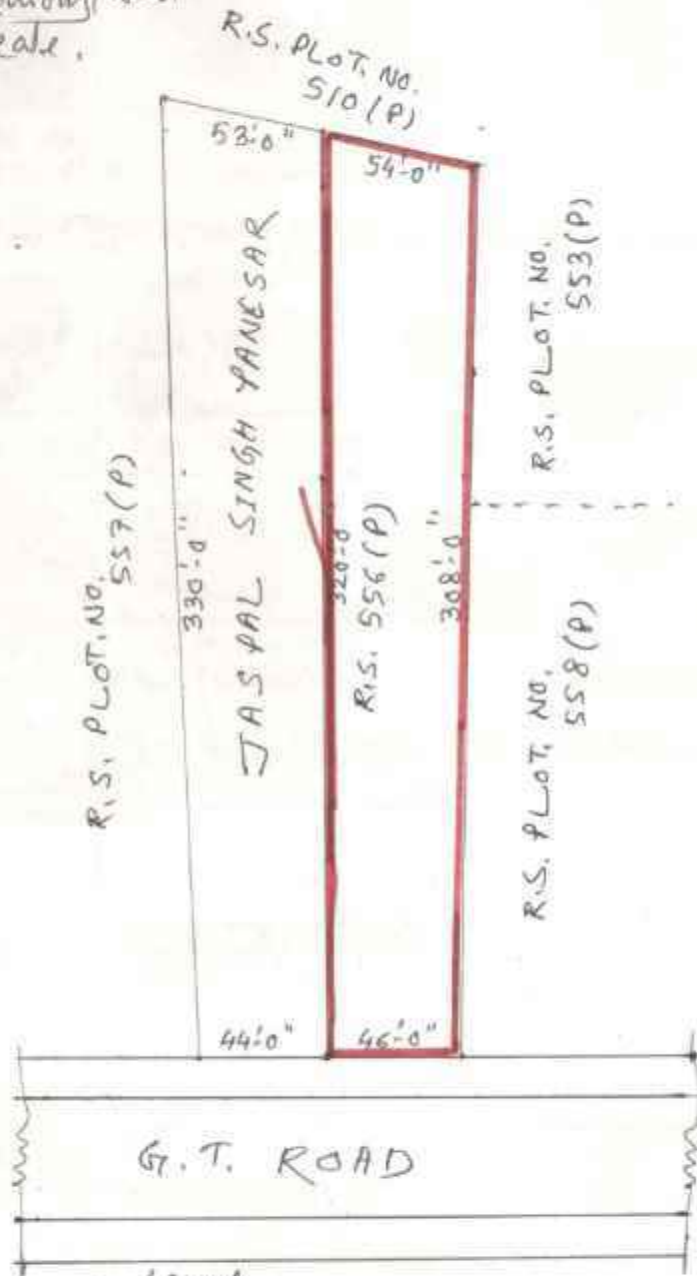

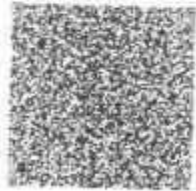
